Instructions to Bidders

Auction closes at Midnight, February 14<sup>th</sup>, 2011. Mailed Bid Sheets must be received at the Pinehurst P.O. in time to be sorted into boxes by 11 am that day. Bid Sheets sent as attachments to e-mails must bear a Date/Time before February 15, 2011.

I will attempt to promptly confirm receipt of all Bid Sheets. I will "reply" to e-mails and place one telephone call if no e-mail address is provided.

Ask any questions, or request additional scans, as early as possible but not later than February 10<sup>th</sup> for reply by e-mail.

Fill out the Bid Sheet completely, and sign it. In the event you decide to change one or more bids later, be sure to mark the replacement Bid Sheet as such.

On the Bid Sheet, you are asked to record the stated Minimum Bid, aka Reserve, designated by the Consignor to minimize the possibility of entering an invalid Bid.

Accept my apologies if you wish to bid on more than ten lots and have to make a second copy of the Bid Sheet (I hope I have that problem!)

If you wish, record your comments and suggestions for our June 2011 auction in your transmittal e-mail or on the back of your mailed submission.

And while you are thinking about it, put together a packet of up to five New York State items of postal history for consignment to the June 2011 auction!

Lot #15 #210 Tied by 28mm WEST GALWAY, N.Y. (Fulton) duplexed CDS w/ five point star in circle killer. 12/31/1885 to Springboro, Penna. Amsterdam, NY transit and Springboro PA marking on reverse. Carefully opened right. Corner wear and general soiling but sound. Min: \$1



**Lot #16** Ms Deposit, NY (Broome) FLS to Kensington, Pa. datelined 7/2/1847 (vs. 7/19/1847 LKD) Manuscript 5<sup>c</sup> rate for business letter on fine grey blue paper. Min: \$1



Lot #17 Ms Wassaic, N.Y. (Dutchess) FLS to Pine Plains, NY 3/24/1855 (vs. 2/26/1855 EKD) Ms. Paid 3<sup>c</sup> Short business letter on fine paper. Min \$1

**Lot #20** 30mm PENN YAN N.Y. to Pine Plains, NY rated 18<sup>3/4c</sup> and marked Paid DBP with PAID hand stamp. Datelined May 5, 1838, a new LKD. Content refers to enclosed draft apparently not reflected in rate. Sound paper. Min: \$1



Lot #21 FLS identified as earliest known correspondence from Carmel, NY (now Putnam, then Dutchess) dtd 4/29/1809. Fully described in March 2008 Excelsior! and accompanied by copy of the 3 page letter. Fragile paper with separations common to letters of this age. Min: \$126



Lot #22 Well struck dark blue 30mm LODI NY (Seneca) town/county mark w. five point star killer on fine UX5 postal card of 12/24/1879. Addressed to Watkins, NY (Schuyler 1852-1926). Min: \$11



Lot #23 2 strikes of 30mm LINDENHURST N.Y. duplex CDS tie 3 color 13<sup>c</sup> franking to war-rate registered mail to Hammondsport, NY (Steuben). 2 strikes of Lindenhurst registry DC on reverse with legible Hammondsport DC registry mark. Rough opening slightly affects postmarks. Min: \$11



**Lot #24** Handsome red strikes of UTICA N.Y. (Oneida) double line oval and PAID in scroll with ms 6<sup>c</sup> rate dated 10/29/1839 in legal contents addressed to Clinton, NY (Oneida). Noticeable docketing & file fold. Ex-Lounsbury. Min: \$16



**Lot #25** Elaborate advertising cover bearing #501 3<sup>c</sup> tied by 22mm Universal BUFFALO NY (Erie) machine w. large "2" in dial and small "c" in killer. 3/30/1918 war rate. Very clean. Min: \$21

**Lot #29** 1850 FLS with complete blue 30mm BALLSTON, N.Y. (Saratoga) CDS and blue "X" 10<sup>c</sup> rate hand stamp for unpaid delivery to Franklin, Oh. Thin but sound paper contains personal correspondence between brothers. Min: \$6



Lot #30 #65 on embossed corner card cover of American Linen Thread Co. of Mechanicsville, Saratoga Co., N.Y. Light strike of 30mm MECHANICSVILLE N Y DC to Pawtucket, RI. Docketing shows postmark to be 4/26/1864. Few creases & wrinkles. Gently opened. Min \$11
