CINCOPEX 1992 UPDATE

The invitations have gone out to last year's CINCOPEX exhibitors, the postal cards have been returned. Our Poll shows that 16 of our members intend to submit 115 6-page frames of competitive material or, if 16-page frames are available, would submit the approximate equivalent of 46. This is hardly enough for a separate ESPHS-sponsored show but is excellent in a joint effort with an established event such as CINCOPEX.

The situation with respect to 16-page frames is still unresolved. The Rochester Philatelic Association Champion-of-Champions frames can be rented, the cost of rental, transportation and insurance puts them beyond reasonable financial reach of a regional show. The Albany Fort Orange Stamp Club has 16-page frames available for loan at a reasonable cost, however it is reported that repairs and possibly new plexiglass is needed to place in exhibit condition.

Another avenue does exist. Your 25th Anniversary Committee has located a cache of 16-page frames in good condition, complete with supports, separators and glass, that is for sale at an extremely attractive price. There are 50-plus units, each unit with four 16 page frames - a total of 3,200 plus pages.

The ESPHS is not in the exhibit business and cannot envision acquisition of these units. CINCOPEX has an inventory of 6-page frames adequate for its needs but if storage could be assured might bite the bullet. For the present, 6-page frames hold center stage.

On other matters, a decision has been made to hold an anniversary luncheon on Saturday, October 17th, the first day of CINCOPEX '92, followed by our regular Fall membership meeting. The CINCOPEX awards banquet follows in the evening so plan to make a gala day of it. Come early, visit the exhibit and bourse, have lunch, attend the meeting, then enjoy dinner at the awards banquet.

MINUTES OF THE SEMI-ANNUAL MEETING OF THE EMPIRE STATE POSTAL HISTORY SOCIETY OF OCTOBER 12, 1991

The semi-annual meeting of the ESPHS was called to order at 2:07 PM by President Margulis. Approximately 20 members and guests were present. The meeting was held at the Masonic Temple in Sidney, NY, site of CINCOPEX '91.

What did the members think about also holding future meetings at stamp shows? George Bernadt remarked that there was too little time available to attend a meeting and see the show. Other comments were that members who are also dealers with a table at the show are not able to attend the meeting. However, Society presence at a show helps the show and this is a positive aspect. The general lack of time to see the show and spend time at the meeting was repeated. The consensus among those present was that the situation posed too many problems.

President Margulis said that moving meetings out of Utica would increase attendance.

John Azarkevich remarked that the time of the meeting was not given in the Bulletin. George Bernadt said our meeting locations must be centrally located for the greatest good.

It was announced that the roof had collapsed at Karrat's Restaurant, the frequent site of our meetings, and this may preclude us from returning there. Would we be able to meet at Karrat's in May 1992 even if we wanted to?

President Margulis described his plans for a special 25th anniversary edition of the Bulletin. This would be issued in September 1992 and be about 60 pages in length consisting of postal history articles.

It was also announced that the Executive Board had agreed to split out the Society news bulletin from the postal history article journal. The duel publications would start in 1992 after the next issue of the Bulletin was released.

The proposal to amend the by-laws to increase dues from \$5 to \$10 per year was put to a vote, and carried. The membership was given notice of the proposed by-law change through the Bulletin. Mail votes were very few with three ballots received in opposition and five in favor. The need for the increase was briefly discussed. Society expenses had simply overtaken the revenue based on the \$5 per year dues structure.

It was reported that the Executive Board had approved in principle the establishment of sustaining and/or patron memberships. These would require additional amendments to the by-laws to enact. This idea shall be further developed and duly proposed.

Ongoing publications projects were briefly mentioned. President Margulis said we should update the NYS manuscript post office book. George Bernadt is working diligently on a New York State stampless cover catalog. Other projects are likewise possible. The publications committee should meet to discuss this topic more fully.

Lou Call said that the Mobile Post Office Society has information on mail routes and rates that could be valuable to the ESPHS. Lou will look into a possible joint research effort between ESPHS and MPOS. This would cover RPO, HPO, and waterway mail routes.

Representing the 25th anniversary committee, Ken deLisle discussed plans for October 1992. ESPHS had explored having its anniversary events be affiliated with CINCOPEX '92 in Rome. The dates (October 17-18, 1992) and location are already known. The members present endorsed this general plan.

President Margulis said he favors having ESPHS join the Federation of Central New York Philatelic Societies. The idea was discussed. Bill Hart indicated that the Executive Board should duly consider this idea. The Secretary shall look into the costs and conditions.

John Azarkevich stated that the Bulletin exchanges that ESPHS has do not benefit the members since it is impossible to share the publications we receive with the general membership. President Margulis said exchange arrangements were useful for sharing information.

President Margulis suggested that future ESPHS Bulletins could be theme issues. Aspects of exhibiting could be one such theme.

Members asked where and when the annual meeting would be held. Joe Rowbottom said he would find out if Karrat's would be available in light of the roof collapse there.

Volunteers are needed to provide ESPHS materials to local stamp shows. What sort of materials do we have for this purpose? The Society should explore how best to produce effective propaganda material. George Bernadt suggested a single page informational sheet would be a good idea.

The meeting was adjourned at approximately 3 PM.

MINUTES OF THE MEETING OF THE EMPIRE STATE POSTAL HISTORY SOCIETY OF MAY 3, 1992

President Margulis called the meeting to order at approximately 1:30 PM. Twenty three members were present. The 1992 annual meeting was held at Karrat's Restaurant, Utica, N.Y.

John Lange acted as a substitute Secretary-Treasurer at the request of Maris Tirums who was unable to attend.

A membership report for 1991-1992 was presented.

Treasurer's report for 1991-1992: see elsewhere in this issue of the <u>Bulletin</u>.

Dave Proulx introduced as a guest Bill Apel, president of the Federation of Central New York Philatelic Societies. Bill welcomed us to the Federation, and stated that any of our members are welcome to come to Federation meetings, and that he expected us to assign two delegates to represent ESPHS. The next Federation meeting will be at Karrat's on the second Sunday of June, June 14. If an auction is held, ESPHS members are welcome to submit lots.

President Margulis appointed Lou Call and Robert Harris to be our delegates to the Federation. They accepted.

Ken deLisle and Lou Call gave a joint report on the plans for our 25th anniversary celebration to be held in conjunction with CINCOPEX '92 at Rome on October 17-18, 1992.

a) deLisle announced that he had sent out inquiries earlier in the year to previous exhibitors, asking for expressions of interest as to how many frames would possibly be entered. He has, to date, a total of 46 sixteen page frames or 107 six page frames as a probable total. He still hopes to hear from others, and would welcome more cards.

While these are not firm promises, they do give the people who are doing the planning a rough idea of how many frames are needed just for ESPHS.

b) Call stated that plans are going forward to have a luncheon on Saturday, October 17 (Saturday rather than Sunday was the choice of those present at today's meeting). Call's next step is to contact Franklyn Rudd to see if we can get the Polish Hall for that time.

Robert Harris gave a presentation on what he called "A New Tool for the Postal Historian:

The Postal System in NY in 1839."

Harris stated that this item had three parts, a large folded 30"x40" postal map, contract specifications (a description of each route), and post office receipts. There would be about 72 pages in this booklet with the map inserted in a pocket in the booklet. The price is \$28 postpaid plus NYS tax where applicable. The map is also available alone at \$15 plus tax, unfolded, mailed in a tube postpaid. Any orders from ESPHS members may be sent direct to the publisher:

Printer's Stone, P.O. Box 30, Fishkill, NY 12524

The publisher will donate 10% of the subtotal (\$28 or \$15 or \$43) to the ESPHS to constitute a fund in support of the non-periodical publications of the Society, if orders are received prior to the August 27-30 APS show, i.e. this is a prepublication offer. Orders must indicate they are from an ESPHS member in order to get the rebate.

Lou Call and Martin Margulis encouraged members to also enter postal history material in other stamp shows in the State. Bob Harris suggested that ESPHS have some frames containing NYS material which would rotate between cities having shows. A summary of these and other comments was that we should use the Federation "Insider" page that is now available to us to list exhibitors and the number of frames of material with titles, or use this "Insider" page to publicize ESPHS and the fact that postal history is interesting and is available for viewing.

Election of three directors for three year terms, May 1, 1992-1995, was the next item of business.

This matter was quite contentious. Dave Proulx stated that a ballot should not have been included with a self addressed envelope and a solicitation for election of three directors, when six were on the slate.

Jack Haefeli stated that to his knowledge, the solicitation for election and the ballot were separately mailed by different people, and that the ballot was not combined with an election plea for specific candidates. Proulx stated he thought the whole process was unethical, and made a motion to rescind the election results. The motion was seconded. During further discussion, two members insisted that they had never received ballots.

The acting secretary stated that anyone who had not voted by mail ballot was welcome to do so now. Haefeli stated that if the motion was passed, he felt that it would be an illegal action since he felt that the requirements of the Constitution had been met. The motion to rescind the election results (the mailed in ballots) was defeated by a vote of 9 to 7.

Seven members then voted, and their votes were tallied and added to the mail ballot totals. The two members who had previously complained that they had never received ballots had their second votes invalidated when the voting record showed that they had voted already by mail (incidentally for the same candidates). The final tally showed the following results:

George Bernadt - elected with 70 votes Ken deLisle - elected with 66 votes Alan Parson - elected with 45 votes William Hart - 39 votes Charles Sweeting - 22 votes Stephen Matte - 17 votes

Several suggestions were made to improve the election process:

- 1. "The President shall each year call for nominations for offices to be filled." The quotation marks indicate that this is from Article 4 of our by-laws. The most direct way of doing this is by timely announcement in our Bulletin or Journal.
- 2. The request for nominations shall be timely enough to enable the members a reasonable amount of time to make them, secure the nominee's concurrence, and to have them received by the "committee on elections" (Art. 4, Sect. 3) by the required March 20 deadline. This will then give the election committee enough time to prepare and mail the ballots, and get them back in time to meet the "three days prior to the annual meeting" requirement of Art. 4, Sect. 3. Dates for these steps should be established by the Board.
- 3. The ballots should be signed by the voter, and the requirement of putting the voter's name on the outside envelope deleted.
- 4. Article 4, Section 3 expressly gives members the right to cast their ballot in person at the annual meeting. This then, makes it necessary to keep a record of who has previously voted so as to prevent people from voting twice as was unintentionally done at this meeting.

Perhaps the process of permitting voting at the meeting is unnecessary? Is there a suitable alternative?

The preceding suggestions as well as others shall be considered by the Board.
