

# Minutes of the Annual Meeting Sunday, May 5, 1996 Graziano's Casa Mia Canastota, NY

- 1. Fourteen members present. Portions of meeting were held concurrently with the Executive Board meeting.
- 2. NYS Doane Cancels—proposed book edited by Maris Tirums. Significant further input has been received although further input will be welcomed. The tabular compilations are essentially complete with anticipated publication late in the year.
- 3. Manuscript Post Offices of New York State—proposed supplement edited by Douglas Penwell. A status report was not available, but based on past conversations, we are sure he would welcome further input (town, county, date). Send to Douglas Penwell, PO Box 3525, Glendale, AZ 85311-3525.
- 4. Postal Markings of New York State 1792-1856 by George Bernadt, published in Oct. 93. ESPHS has one remaining copy for sale (the 3 ring version); then it will be sold out. A revision is planned for 1997 or 1998, but George welcomes input at any time, preferably a photocopy with the markings identified and the date included. The marking colors are important—data includes manuscripts are well as handstamps.

#### AND THE WINNER IS .....

At Rochester's ROPEX '96, held April 12-14, we offered the usual silver trophy and furnished certificates to be awarded qualifying exhibits of New York State postal history. Our award rules restrict the silver trophy in this manner: A trophy-winning exhibitor in any show cannot qualify for the top ESPHS award until two years have elapsed after the win. Since the BEST NY STATE exhibit at Rochester was a recent awardee and although there were 5 New York postal history exhibits there were not three or more qualifying competitive exhibits. No silver was granted at this show. President Call and the RPA committee did, however, recognize the BEST NEW YORK STATE exhibit in an appropriate manner.

ROPEX '96 AWARDS and our certificates for New York State postal history went to:

JOHN A. LANGE, JR.—Saratoga County, NY Stampless Covers, 1803-1855—judged the outstanding NYS exhibit and took the DR. LOUIS T. CALL JR. PRESIDENTIAL AWARD, (personally placed in competition by our president) for Best Exhibit Displaying an Understanding of NYS Postal History. Lange's entry also earned a *ROPEX '96 VERMEIL*.

WILLIAM J. HART—Postal Marking of NY State 1900-1910—ROPEX '96 SILVER

AUGUSTA GELFAND—Postmarks of Syracuse, NY—ROPEX '96 SILVER BRONZE and Maurice Apfelbaum Gold Medal (Best first time exhibitor)

MARTIN MARGULIS—Manuscript Postmarks of Westchester County. NY—ROPEX '96 BRONZE

The crème de la crème RPA GRAND AWARD (Proof set of 1996 Olympic coins) went to our members DR. GUY R. DILLAWAY for his magnificent 7-frame CAPE OF GOOD HOPE POSTAL HISTORY 1853-1865. This exhibit was further recognized with the Postal History Society gold medal for Best Postal History exhibit and a ROPEX '96 GOLD.

Member WALTER J. ORTON III with his 10-frame Compendium of Railroad Cancellations Applied to the Documentary "Battleship" Revenue Stamps of 1898 garnered a *ROPEX '96 VERMEIL*, an APS medal and ribbon for Research Excellence, the American Revenue Association Gold Ribbon and Certificate and the RPA George LeFebre Award for Best Non-Thematic Exhibit by a RPA member.

In addition, Dr. Call was presented wit the prestigious LARRY R. MORIARITY MEMORIAL AWARD, the United Postal Stationery Society Blue Certificate for Best Postal Stationery and *ROPEX '96 SILVER* for his 5 frames of U.S. First Issue Stamped Envelopes.

Another of our members, ALBERT GUENZBURGER, was awarded on of those scarce *ROPEX* '96 VERMEIL medals for his 5-frame showing of Federal Republic of Germany's First Definitives—West Germany's Posthorn Series of 1950-1951.

We heartily congratulate our winning members. Certainly, it is the best showing we have ever mounted at a nationally-ranked Champion of Champions show. Those of us with reluctance to enter the big ones should review this award list and THINK 1997!

It has been noted that some of our members are under the impression that we are using the listings in the ASCC as material for our NYS 1792-1856 handbook. NOT SO! That is why it is imperative that members (or non-members, if they would) send me all available data on their covers. Only then can it be as complete and as accurate as possible.

Several of you have been most co-operative-to them my heart-felt thanks!! The listings for the counties they collect will be greatly expanded because of their help. Descriptions of any cover you may have that are not now listed in our handbook would be very greatly appreciated!!

The fact that marking is not presently listed does not mean that it is scarce but simply that no description of same, no matter how common it may be, has been sent me. It would be practically impossible for me to have copies of all, even the most common covers. That is why your co-operation in this project of updating our handbook is so important!!

Photocopies are always best but an accurate description of each cover will do very well. Always measure circles and boxes from the CENTER of the outer line to the CENTER of same directly opposite. All other markings should be measured from one extreme to the opposite extreme (except for smears) both horizontally and vertically in that order. Be sure that colors and dates (where available) are included on all of the above.

Again, I appeal to your interest in furthering the study of NYS postal markings both handstamps & manuscripts, to take the time to assemble this data and send it to me at the earliest opportunity!
