## ESPHS Executive Board / Annual Meeting combined Minutes, May 3, 1998 - Graziano's Casa Mia Restaurant, Canastota, NY

Members present: Bernadt, Calkins, Fonda, Guenzburger, Hart, Haefeli, Lange, Ludin, Matte, Parsons, Przepiora, Rowbottom, Sweeting (& Mrs. Sweeting), Tirums, Tuttle and Wiley.

1. Auction Manager's comments: The March 1998 Auction was the first for Manager Bill Hart. Bill encourages more people to bid (there were 14 in the March auction). The Exec. Bd. supports Bill's intention to withdraw lots or reject bids which reflect abnormally low bids. This will encourage consignors to submit material with some degree of protection, although minimum bids can continue to be used. Overall, Bill feels the March auction was a success.

2. Status of book revisions/new books:

- 2.1 MSPO of NYS, Penwell -- near completion
- 2.2 Doane Cancels, Tirums - About a year away
- 2.3 Star Cancels, Williams - In progress
- 2.4 Postal Markings of NYS, Bernadt - In progress
- 2.5 200 Years of Cayuga County, NY Postal History, Sweeting. Manuscript completed. Lacks only a page identifying ESPHS as the publisher. Haefeli to prepare and forward to Lange (Lange to provide Haefeli with sample pages showing style/fonts of manuscript). Charles showed one copy that he has had privately hard bound. The paper used was Hammermill "Copy Plus", an archival grade paper which he purchased for \$3.50/ream, a surprisingly low price. Estimated publication costs for 50 or more are:
  - Paper, if same as sample, 346 pages (173 sheets) . \$ 2.00
  - Printing, using BOCES, . . . . . \$ 6.00
  - High Quality (heavy) lead in sheet, with title, . \$ ?
  - Hardcover Binding, same as sample, Red Color, . . \$10.00
  - Total cost, per copy printed . . . . . \$18.00

The actual cost per book will be slightly higher because of the copies needed for copyright, authors copies and review copies. The probable selling price will take these factors into consideration. Normally, we like to give a 20% discount to members and a 40% discount to volume buyers of 5 or more.

John Lange has the manuscript; the plan is for Bernadt/Lange to arrange for the printing, Sweeting to take care of the binding. The Budget will include \$2700 for costs, sufficient for an estimated 150 copies. Secretary's note: The timing was not discussed; BOCES shuts down in early June so this may cause a delay in printing.

Actual publication times for the other publications cannot be determined at this time. An allowance for one or more of \$2500 is to be included in the Budget, replacing a previously proposed breakdown for individual books.

3. John S. Whittlesey Memorial Award: The interest from the \$2000 CD will be about \$120/year. A committee is needed to implement the approved recommendations of the temporary committee headed by de Lisle. Parsons (Ch.) and Tuttle appointed

4. Awards Committee, Albert Guenzburger, Chairman: The proposed revision dated March 26, 1998 was presented and approved by the Board. The Awards Chairman has an increased budget of \$500, which is intended to be used for (a) Increased Award value, and (b) More awards. The hoped-for benefit is more exhibitors entering NYS material into local, regional and national shows. STEPEX 98, the Southern Tier-Elmira Stamp Exhibit and Bourse, to be held in Elmira on Oct. 16, 17, 1998 will be our first effort. The qualifying number of entries was promised.

## Annual Meeting Minutes (continued from page 1)

5. Finance Committee Vacancy: Ken de Lisle wishes to retire as a Director (term ended April 30, 1998). Ken is also a member of the Finance Committee. *Per* Sect. 4a, only a Director can be on the Finance Committee. *Per* Sect. 6 of the Bylaws, "Each elected officer shall hold office until his or her successor is duly elected and takes office." There were no volunteers and likewise no director candidate. Therefore, *per* our Bylaws, Ken will continue both as a Director and member of the Finance Committee until a successor is elected (May, 99).

6. Secretary/Treasurer's Report for fiscal 1997-1998. This is a 6 page report (available to any member providing an SASE.) It was reviewed by the Finance Committee and approved prior to the meeting. The portion covering Expenditures/Revenues (pages 1-4) was approved by the Board/membership. Page 5 contains a comparison with money budgeted for 97-98 vs. actual. Page 6 dated 9/21/97 contained a proposed budget which was approved with the following changes: a. Expenditures, add \$2700 for Cayuga Co. PH book costs, b. Expenditures, add \$2500 for other publication costs of possible new books and delete \$1190 from the 4/21 proposal. c. Add \$15 for Federation membership.

## FALL MEETING OCTOBER 17 IN SOUTHERN TIER AT STEPEX'98

Due to cancellation of CINCOPEX'98, the fall meeting of the Empire State Postal History Society will be held October 17 in conjunction with the annual show sponsored by the Elmira Stamp Club (known as STEPEX, an acronym for Southern Tier-Elmira Philatelic Exhibition). STEPEX is held each year at the Arnot Mall, located at Exit 51 off Route 17, just west of Horseheads. The Mall and nearby areas offer a variety of shopping, dining and sightseeing experiences, including Finger Lakes wineries, museums (Corning Glass Center, National Soaring Museum, National Warplane Museum, etc.), State parks (Watkins Glen, etc.) and historic points of interest. STEPEX'98 will be held Friday and Saturday, October 16 (10 a.m. - 9:30 p.m.) and October 17 (10 a.m. - 8 p.m.). The exhibits and bourse will be located in an open area of the Mall with security provided. STEPEX'98 exhibiting information and entry form can be obtained from Alan Parsons, 809 Holley Road, Elmira, NY 14905 (607-732-0181). Both 9 and 6 page frames are available. Society exhibitors should reserve frames early. Further information on Society activities at the Show Oct. 17 will be published in the September Bulletin and available at the STEPEX'98 hospitality table.

The 2nd Annual Competition for the *Kenneth R. de Lisle Award* will be held at the fall meeting. Members are encouraged to show a four page exhibit of material relating to the postal system in New York State. The exhibit does not have to conform to traditional postal history concepts and may include ephemera. There are no "rules" as such: the exhibits will not be judged, but voted on by the members present.

The winner member will receive the award, an attractive wooden plaque in the shape of New York State, with his or her name engraved thereon, to be presented at the society's next annual meeting in May, 1999. John Lange, winner of the 1st Annual Competition, has announced that he will not be competing in this upcoming competition.
