FALL MEETING OCTOBER 17 IN SOUTHERN TIER AT STEPEX '98

The fall meeting of the Empire State Postal History Society will be held October 17 in conjunction with STEPEX '98, the annual show sponsored by the Elmira Stamp Club.

STEPEX is held at the Arnot Mall, located at Exit 51 off Route 17, just west of Horseheads. The Mall and nearby areas offer a variety of shopping, dining, and sightseeing experiences including Finger Lakes wineries, museums (Corning Glass Center, National Soaring Museum, National Warplane Museum, etc.), state parks (Watkins Glen, etc) and historic points of interest.

STEPEX '98 will salute the new facility for the National Warplane Museum just opened at the Elmira-Corning Regional Airport, located approximately two miles from the Mall.

Since publication of this notice in the June *Bulletin*, STEPEX has rented 16-page frames in lieu of the 6 and 9-page frames described in the June notice. Use of these frames will provide better security for the exhibits; they are the standard size and type used for WSP shows. A STEPEX '98 Exhibiting information and entry form is included in this bulletin on pages 7 & 8; please refer to it for further information regarding the show.

Three exhibits of New York postal history have already been entered in STEPEX '98, thus insuring a society trophy pursuant to new exhibiting award rules adopted at the annual meeting.

A Board of Directors meeting is tentatively scheduled for 4:00 pm on October 17 followed by the semi-annual membership meeting to include the 2nd annual competition for the Kenneth R. DeLisle award for 4-page exhibits of material relating to the postal system in New York State. Society members should check at the Elmira Stamp Club hospitality table for any changes in this meeting schedule and the location of the meeting.

Our Secretary/Treasurer, John Lange, will be coming to STEPEX '98 and has graciously offered to transport exhibits from the Capital District area, assuming the exhibits can be brought to his house or he doesn't have to travel far to get them. Do You Collect a Popular County?

Postal history dealer Jim Forte maintains a web site that houses his commentary on the postal history of all the 50 states. This is what he has to write about New York State:

"The market for New York covers is completely dominated by individual county collectors. The market for some counties is quite strong. The market for other counties is non existent. In general, western New York and the counties around New York City are in the most demand. New York city is collected, but New York county is the weakest part of the city. Except for those who collect Doanes and Long Island, most collectors will not tolerate 20th century covers. There is plenty of opportunity for any potential New York collector, regardless of which county they choose to collect.

"1997-1998 Update: There is little overall change for the New York market. Below is a rating of the level of demand of the New York counties on a 1 to 3 scale. Counties rated 1 are at best lightly collected. Counties rated 2 have a visible collector base. Counties rated 3 are avidly collected." *(ed. note: a table and map have been summarized by the information below)

"200 Years of Cayuga County, NY Postal History"

This book, just published, is a comprehensive compilation of 40 years of collecting and research regarding 200 years of postal communications throughout Cayuga County, New York.

The book includes a Table of Contents and a Forward, followed by a brief description of the origins of Cayuga County. Next are segments covering manuscript cancels, straight-linecancels, county and postmaster cancels, Cayuga County precancels, early Air Mail Service, local First Day Covers and philatelic notables.

The remaining text and graphics relate to individual post offices which are treated in alphabetical order for easy reference. For each post office, documentation is given for postmaster appointments, followed by pictures and comments about them. Site location maps are included, as well as illustrations of mail used at these post offices.

The book is profusely illustrated with large, easy-to-read bold type. It will be of interest to both historians and genealogists.

"Why I Live at the Post Office"

"From presidential politics to the passing of the horse and buggy, much can be garnered from the comings and going of our local post offices.

"One of the first things our forefathers did upon stepping foot on solid land was open a post office and since then every crossroads or backroad cluster of houses, sported, at one time, a post office.

"It was not until 1808 that daily service started in Cayuga County's three main post offices, Aurelius, Scipio, and Sterling.

"Now, Oswego resident Charles Sweeting has traced the history of the county's post offices in his book, '200 Years of Cayuga County Postal History.'

"'I grew up in Auburn and my dad worked at the Auburn post office for 38 years,' Sweeting said. 'I've been planning on this book for years.'

"Sweeting, a lifelong philatelic aficionado and stamp collector, said he had been collecting materials for the book for close to 40 years, but lacked the time to write until retiring from SUNY Oswego six years ago.

"The book tracks the history of mail delivery at many of the well-known stamp dispensers, such as Auburn, Cato, and Moravia, as well as the lesser known short-lived establishments who (sic) have long since had their stamps canceled.

"Many are the four-corner country stores and hamlets, which were made extinct by the advent of the automobile, paved road, new industries and new ways of life.

"'In a lot of these places, once the post office closed up, they lost their identity,' Sweeting said. 'But every office had something of interest.'

"Some opened and shut with a week, or like Hector, lasted barely two years before being swallowed up by Seneca County in 1804. In King Ferry local farmers Sidney Goodyear and son Sidney Jr., ran the post office out of their home on Atwater Road from 1874 to 1903.

"Fair Haven was a regular letter senders paradise with three offices, Fair Haven, Little Sodus, and North Fair Haven.

"But it was not all special delivery and first class. Many, such as Meridian's Carroll Dudley, balanced tobacco farming and running the local power and light company along with the duties of the postmaster.

"Presidential politics also took its toll. In 1861, Hiram H. Alley, a Republican, was appointed Moravia post master after Abraham Lincoln's election; replacing Wright Tourtellotte, and ending a long string of Democratic and Whig postal bosses.

"And the hours were long. Ruth Larsen, who retired as post master at King Ferry, had to handle five deliveries a day, worked 11 hours a day, six days a week, with a mere half hour off for lunch, all for a whopping \$1,700 a year in 1943.

"As for Sweeting, there appears to be no time to while away his retirement working on his stamp collection.

"'I'm working on Oswego County now,' he said. 'I live here but after all those years I had to get Cayuga County done first.""

STEPEX '98 (Southern Tier-Elmira Philatelic Exhibition)

Exhibitor Information and Entry Form

The Show is Friday and Saturday, October 16 and 17, 1998, at the Arnot Mall, Route 17 (Exit 51), Horseheads, NY. Hours are 10:00 a.m. to 9:30 p.m. on Friday and 10:00 a.m. to 8:00 p.m. on Saturday.

The purpose of the Show is to bring stamp collecting to the general public through exhibits by, and contacts with, area collectors and dealers. Both adult and junior exhibiting is encouraged and will be judged in separate competitions.

Exhibit frames hold 16 vertical album pages which can be $8-1/2 \times 11$ inches or as large as $9 \times 11-1/2$ inches. Use of frames is free of charge to Elmira Stamp Club members and junior exhibitors; \$4.00 per frame to others. The number of frames available is limited; they will be allocated on a "first come" basis, and, if oversubscribed, to Elmira Stamp Club members. No more than 5 frames may be used for any exhibit. No individual may enter more than 2 exhibits, unless the frames have not been fully subscribed by 10/1/98.

Closing date for entries to be listed in the Show program is October 10, or until all frames are filled, whichever is earlier.

The Club will act in good faith to protect the material displayed and will hire professional security to watch the exhibits between 10 p.m. Friday and 8 a.m. Saturday. At all other times Club members will be assigned to the area. Insurance coverage will also be obtained by the Club. In the unlikely event a loss occurs, the Club, its officers, or any of its members cannot be held liable.

Exhibits may be given to Al Parsons at the September Club meeting (Sept. 15), mailed or delivered to Al Parsons at One West Church Street, Elmira, NY 14901 (to be received no later than Oct. 15) or delivered to the Mall between 8:30 and 9:30 a.m. on Friday, Oct. 16. Exhibits will be dismantled Saturday, Oct. 17, immediately after 8:00 p.m. If you cannot pick up your exhibit in person, make arrangements with someone to do this for you. Returns will be made by mail if the Club is provided with a mailing container, necessary instructions, and reimbursement for the mailing expense.

Silver and bronze awards will be made for both adult and junior exhibits based on point scores from a jury of Federation judges. There will be balloting by Show visitors for the most popular exhibit (the Club reserves the right to reject ballots for any reason). Awards in specialized categories such as N.Y. postal history (ESPHS awards) and first day covers (AFDCS awards) will be made if criteria are met. Awards will be presented at the Club's annual banquet.


