## **PRESIDENT'S MESSAGE**

---

It's been an exciting year for the Society, certainly in the areas of exhibiting and publishing, but also in the area of "new initiatives."

**Exhibiting:** We won both the multi-state postal history exhibiting competition, with six states participating, at ROPEX in June and the single-frame postal history competition with Pennsylvania and New Jersey at Philadelphia National Stamp Exhibition in October.

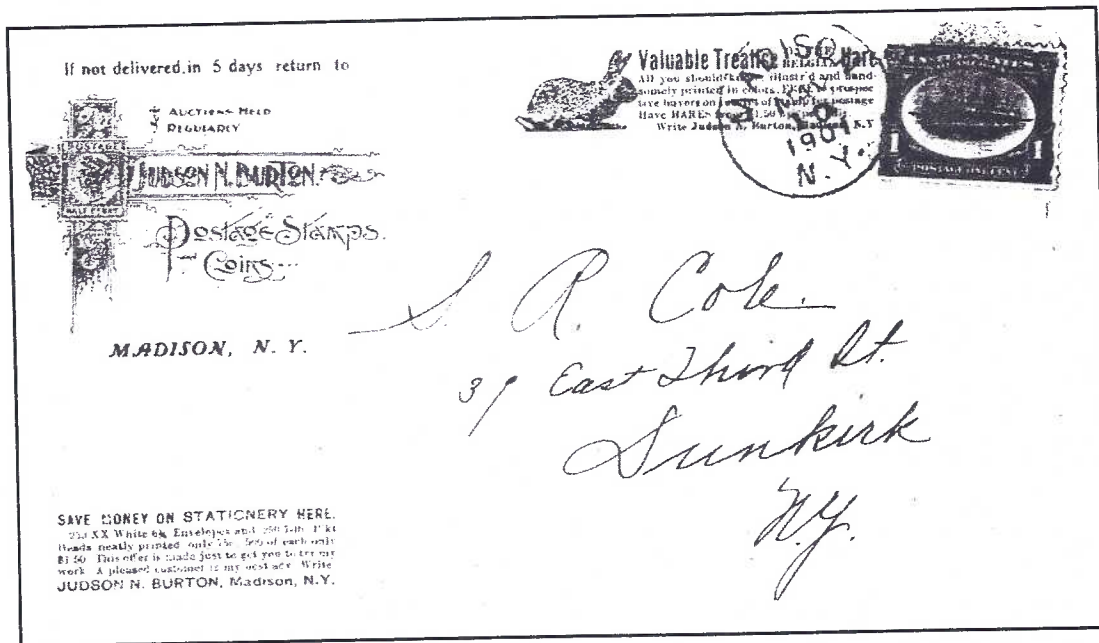
**Publishing:** (1) *Excelsior!* used color for the first time and continued successful transition to new editorship. (2) Our website not only has become more accessible but has added new pages and new features and become more useful. (3) Society director Gerry Wiley produced a CD-ROM of 782 items in his collection to show what could be done with postal history materials using a computer and scanner; each member attending the annual meeting received a copy.

**New Initiatives:** (1) At the suggestion of member Karl Kabalec we are seeking a wider distribution of our publications by contacting libraries already holding some in order to sell them the books they lack. Thanks to Karl's research through the Online Computer Library Center (OCLC), we are able to direct our marketing efforts at the libraries most likely to purchase. (2) We now have a regional representative for New York City and Long Island, and this has prompted a fresh look at the role of the regional representative, preparation of a written job description, and recognition of the need for smaller regions upstate and more regional representatives.

Other noteworthy new developments in the past twelve months include a proposal for a Society library (and a volunteer to run it – see article on page 5), drafting a revised membership brochure and offer by John Nunes to put the draft in final form for printing, the Society's pledge of \$5,000 to the APS/APRL Building Fund, creation of a perpetual award in memory of Charlie Sweeting to go to the winning society in the ten-state postal history exhibiting competition (see article in Sept. *Bulletin*), and ESPHS joining in the State Postal History Registry, a project of the National Postal Museum, with our webmaster, Glenn Estus, agreeing to act as the Society's contact person.

September's *Bulletin* had a full report on the ROPEX exhibiting competition in June, and you'll find an article in this issue of the *Bulletin* on the PNSE competition in October. I mention this here only because I wish to extend my personal thanks and appreciation again to the ROPEX exhibitors and now to those besides myself on the PNSE "team": Ellen Rose, Ada Prill, Ann Trigg, Tom Mazza and Bill Hart. Each made a strong contribution to a satisfying team victory!

The printing on the lower left says "Save Money on Stationary Here." Burton evidently also was a printer as he is offering 250 envelopes & letterheads for 75c "just to get you to try my work."

Next to the picture of the rabbit is written "Valuable Treatise on the Belgian Hare. All you should know, illustrated and handsomely printed in colors. Free to prospective buyers on receipt of stamp for postage. Have HARES from \$1.50 up per pair. Write Judson N. Burton, Madison, N.Y."

So Judson must have been quite the entrepreneur. In addition to stamps, printing and rabbits, I'm pretty sure he had two or three other irons in the fire to turn a buck. Gotta run. Think I'll order up a Penny Black and a pair of Belgians. I hope he won't ship 'em in the same package.

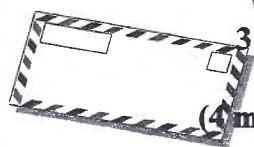

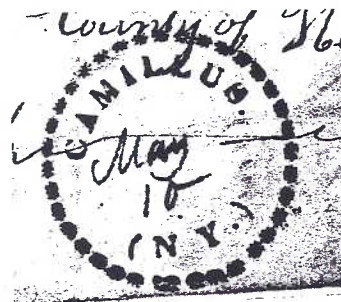

The award, a suitably-engraved walnut plaque in the shape of N.Y. State, will be presented to Frank at the 2005 annual meeting.

Thanks to Society member Joe Christofaro and ESPHS director John Cali for their help in arranging for and assisting with our meeting room at Turning Stone. In the minutes of our Board meeting Oct. 10 you will read that Ada Prill has resigned as our Western New York Regional Representative. I am grateful for all that Ada has done in that role and fully understand her reasons for resigning; I anticipate she will remain an ESPHS member and continue her involvement in other Society activities.

On December 1 I appeared for the Society on WSRadio's APS Stamp Talk with Nancy Clark. Nancy's subject for her program that day was "Collecting by State" and just prior to our segment she interviewed another ESPHS member, Bill Bauer, appearing for the Colorado Postal History Society. The purpose of each 20-minute interview was to bring out unique or interesting aspects of the particular state's postal history in order to encourage its study and collection. ## **ESPHS WINS SINGLE-FRAME COMPETITION AT PNSE**

Empire State took up the challenge from Pennsylvania and came away with all the "glory," i.e., bragging rights.

The challenge, issued to both New York and New Jersey by the Pennsylvania Postal History Society, was to see which of the three states could best show aspects of its postal history in six single-frame exhibits by six different society exhibitors.

The competition was held at the 2004 Philadelphia National Stamp Exhibition, Valley Forge Convention Center, King of Prussia, PA October 1-3. The judges for the postal history affair, Irv Weinberg, Bob Lana and Alan Warren, were picked by the host society, and, of course, Pennsylvania had "home field" advantage! The three judges decided only first, second and third place in the single-frame postal history competition, did not award medals or points to the individual exhibits, and offered no oral or written critique. The exhibits entered by the three societies were as follows:

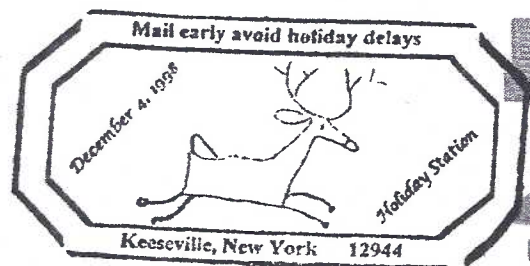

Alan Parsons attended PNSE 2004 on behalf of Empire State and received a warm welcome from Rick Leiby, PaPHS President and Norm Shachat, its Secretary and Editor of Pennsylvania Postal Historian. ESPHS was able to place its informational brochure/membership application on the PaPHS table as well as at the show entrance.

Alan was present at the PaPHS annual meeting during the show, where he reported on the multi-state postal history exhibiting competition held at ROPEX '04, displayed the Charles H. Sweeting Memorial Award, and urged PaPHS to take advantage of its eligibility to compete for this award.

The winner of the tri-state single-frame competition at PNSE '04 was announced at the banquet Saturday evening and awarded "bragging rights."





## REGIONAL MEETING AND SOCIETY TABLE PLANNED FOR SPRING MEGA EVENT SHOW MARCH 3-6

Our newest Regional Representative, Frank Braithwaite of Smithtown, Long Island, is off to a running start! He's looking for volunteers to assist him with a Society table at the Spring Postage Stamp Mega Event, a four-day WSP show sponsored by the ASDA at Madison Square Garden, March 3-6, 2005. He also wants to hold a Society regional meeting at this event, and plans to send a letter to our members in the five boroughs of New York City plus Nassau, Suffolk, Westchester and Rockland Counties to ask their help in planning the meeting.

Frank is a partner in Installations Unlimited, a Smithtown company installing window treatments for Home Depot, Lowe's, Fortunoff and several local designers. Previously with the Long Island Postal History Society, he became a member of Empire State when the Long Island group joined with ESPHS in 2001.

To get better acquainted with ESPHS, Frank attended our fall meeting at Turning Stone, took an active part in the discussions, and won the four-page exhibit competition at the conclusion of the membership meeting. From his comments during discussions it was apparent he was anxious to have our metropolitan New York City and Long Island areas play a more active role in the Society.
