Coming from the east, pass the State Office Building, keep on Washington Ave. past a small park to just beyond Northern Boulevard.

COUNTY POST OFFICE LISTS:

The above two counties (Allegany and Monroe) are the only lists for which extra copies have been saved from the binding of the Federal Post Office book. Members who wish extra copies of any county should let Ken de Lisle know and when enough requests are received to warrant duplication it will be done, at 50¢ per county. Don't send any money, you will be billed when completed and mailed.

CICERO (N.Y.) POST OFFICE:

Martin Toly of North Syracuse supplies this account which was printed in a local paper in May 1973, under the byline of Lona Flynn, Town Historian.

Mail service commenced in the Village of Cicero in 1821, then called Cody's Corners, later changed to Cicero Corners and finally to Cicero. Isaac Cody was appointed postmaster April 7, 1821 and located the post office in his tavern which he had purchased in 1818 for \$90.00. This building was included in what later became King's Hotel. Demolished in 1965, it is the site of the present A. & P. store which is located on the west side of Rte. 11 in the center of the village.

Mail arrived weekly by horseback from Salina. A stage company was formed in 1825 and carried the mails along the route to Watertown, this is principally Rte 11.

Mail was delivered to Cicero on the Syracuse Northern trolley line, which started operations August 27, 1908. Mail was carried by truck beginning about January 1932.

The present Cicero stands on the site of the 128-year old Universalist Church which was torn down in 1960.

BULLETIN FOOTNOTE: The above points up the often wide difference between historical accounts and efficial records. Post Offices of New York State 1792 - 1969, lists this Onendaga effice as being established April 20, 1821, some two weeks after Cody's appointment. The office was known as Cicero at that time and has continued so until today, a span of some 153 years of service.

THE POSTAL BULLETIN: (Contributed by William Seifert Jr.)

The Postal Bulletin is the official publication of the U.S. Postal Service. It is published every Thursday and the subscription cost is now \$13.00 annually. It contains rules, regulations and directives of the postal service.

The Postal Bulletin has many features of interest to a stamp or cover collector and to postal historians. These include announcements of new stamps, first flight notices, stamps removed from sale at the Philatelic Agency and special official slogan cancellations.

Each month a list of new, discontinued and changes in U.S. Post Offices is shown. This is the ONLY official source of this type data readily available. Changes in domestic and international postage rates are announced in advance. Many other items such as postal offenders, fraud orders, stolen money orders, etc., are found.

The Postal Bulletin, as you can see, is an invaluable aid to the collector or postal historian.
