#### EXPRESS MAIL

An interesting note from Petrie's Postal History of Western New York. During the War of 1812 postal routes became so important for military purposes that the Postmaster General Gideon Granger established a special Express Mail which was carried by a relay of post riders. One route from Buffalo via Avon, Bath and Williamsport to Washington made the trip in 4 1/2 days. Seems incredible when one considers the time that it takes today. Immediately after the termination of the war, this service was discontinued.

#### THE LYONS MAIL BAG FACTORY

No doubt a great many of the railway mail clerks, who worked during the first quarter of this century, knew that the pouches, which held the mail, were made in Iyons, N. Y.

Iccally the mail pouches were called mail bags. They were constructed with leather bases and covers, the sides being of heavy cotton cloth. Not only were the pouches made in Lyons, but damaged and worn ones were mended at the factory.

While the industry was closely identified with Myron C. Taylor and his family, mail pouches were made also by William Lauster in his broom factory next to his home on Canal Street in Lyons. Mr. Taylor started making pouches in 1891, but 10 years later, in 1901, Mr. Lauster obtained the contract from the United States Post Office Department.

Mr. Lauster held his contract for only a few years, when he was underbid by William Taylor and his famous son Myron C. Taylor. The elder Taylor had operated a tannery for many years and his son had been involved in the textile industry after his graduation from Cornell in 1894. This gave them a great advantage in bidding for the contract. Mr. Lauster worked for Mr. Taylor as factory superintendent till his death in 1906.

Some time after William Taylor's death, the business was incorporated in 1910 as the American Commercial Corp. with Myron Taylor as President. The business prospered and was a leading industry in Lyons till the first World War. In the meantime, Myron Taylor became interested in other and larger enterprises. The factory closed in the summer of 1921, the building was torn down, the land was deeded to Myron Taylor who, in 1932, gave the land to the Village of Lyons for a park.

The meeting was opened at 2:00 P.M. by President George Bernadt. There were 23 members and 3 guests in attendance.

Minutes of the previous regular meeting (November 4, 1973) were approved as printed. Bernadt spoke on some correspondence received from members regarding more meetings or optional locations and stated this would be taken up in the course of regular business later in the meeting.

Annual reports were received from the Treasurer, Secretary and Awards Committee. Brief summarys were read, with full reports to be printed in the Bulletin. The motion was made, seconded and unanimously passed to accept the reports.

Clifford Tuttle, as Awards Committee chairman, spoke on his experience with other groups in the past year. He requested approval of a request by the Monticello Republican Watchman for permission to use the ESPHS listing of Sullivan County post offices, as part of the "Sullivan Days" newspaper feature this year. The members approved the request. President Bernadt instructed Tuttle to forward our approval, working with the newspaper on credits and publicity.

The Rochester delegation made a formal request for a postal history trophy to be offered at ROPEX 74, in addition to award certificates. Cliff Tuttle showed the silver bowl which had been purchased by the Awards Committee to cover such a request. Although presentation of a trophy is normally subject to approval by the Executive Board on a show-by-show basis, it was left to the discretion of the committee, which must be assured that a minimum of five qualifying exhibits are entered before the bowl can be presented.

A discussion ensued on obtaining a block of exhibits for ROPEX 74 by members. It was stated that a Court of Honor presentation (non-competitive) would be good publicity but that so little time was left between now and the show dates of June 21-23 that a good presentation could not be made. Bernadt ruled that the arrangements for such an event in 1975 could properly be the duty of a regional chairman, the subject of the next order of business.

The action of the Executive Board in setting up three regions, each under a separate planning or program chairman, was then announced. There will be a Metropolitan Region, including Long Island, New York City, Bronx, etc., and southern counties such as Westchester, Sullivan, Orange, Putnam, etc. A study by Emma Koberg shows we have 23 members in this area. The Central Region will include the upper Hudson counties, northern counties and areas west of Albany as far as Utica. A Western Region will include everything between Syracuse and Buffalo. There are 27 members in the central region and 23 in the western region.

Briefly, the members in each region will be encouraged to undertake local meetings, particularly if the gasoline shortage develops again or in the winter if long distance travel is difficult. Bernadt pointed out that the lines are drawn generally and there will be some overlapping. Naturally, all members will be welcomed to any regional gathering no matter what their home address, the main idea behind the concept is that no one would be asked to travel far to attend a meeting. A round trip of 200 miles seems about the limit.

The members present voiced their interest in this arrangement, asking that it be given a trial next fall.

#### MINUTES OF ANNUAL MEETING CONTINUED

President Bernadt announced the appointment of Warren Stevens to be Western Regional Chairman. A tentative appointment has been made for the Metropolitan Region, subject to acceptance. The Central Region is open for appointment.

VP Seifert reported receiving a letter from the Utica Masonic Home Stamp Club, thanking him and the members for their efforts and success in obtaining donations of stamps and supplies. Members are urged to continue this worthwhile project and get in touch with Bill Seifert for details. ANYTHING is appreciated.

The President than brought up the subject of material for the postal history publication Excelsion, to be sent to Cal Hahn. Several persons reported they had sent material or were working on articles. They were urged to complete their contributions so that the next issue could be planned.

Secretary de Lisle then gave the results of the election for three positions as director, for which Koberg, Moore, Prosser and Tuttle had been candidates. Those elected were Tuttle as front-runner, with Koberg and Moore in a tie for the remaining posts. Dave Prosser was runner-up by a single vote, needing only one XX to throw the election into a three way tie. It was pointed out by de Lisle that this proves one or two votes are important and with the results this close every vote counts. Yet, only 63 cards out of 100 were returned, in spite of the ease to mark a pre-stamped, pre-addressed card.

A request from the floor for a new membership roster was answered. The Executive Board has authorized the preparation and printing of a new roster, to be distributed as soon as possible after the dues canvass.

VP Seifert spoke regarding the USPS-sponsored postal history pictorial cancel, used at KAPEX 74 last week. He showed examples of the cancel which features William B. Winne, Albany's penny postman and first letter carrier. Cacheted envelopes are available from him, as advertised in the March Bulletin.

During a discussion on the time and place for our next meeting, Rochester extended a cordial invitation to gather at ROPEX 74. In view of the poor attendance at Rochester by any members except the immediate area last year, it was decided to remain in Utica. Therefore, our next meeting will be held in the same location as usual, Rizzo's Ranch Restaurant, Route 5 west of Utica, on Sunday, June 9, from 10:00 A.M. on.

### SECRETARY'S ANNUAL REPORT

To the President and Members in Annual Meeting Assembled:

The Empire State Postal History Society enjoyed another good year in 1973-74, although membership gains were not quite as rosy as last year. We began the year with 100 members, dropped 7 through resignation or non-payment of dues, added 10 new members and one through reinstatement. Our roster at the end of the fiscal year stands at 104.

The Society's meetings were reduced by the gasoline shortage to only four general meetings, two at Rizzo's (now the Ranch), one at Rochester and one at Sacandaga Reservoir. There was a sectional meeting at Albany in March.

In addition to these general meetings, the Executive Board met once at Rizzo's and once in Albany, at the Inn Towne Motel.

During the year our Bulletin was issued on seven occasions, keeping the members informed on roster changes, meeting dates, noting new publications of the Society, etc.

We also distributed to the members a solicitation for participation in the listing of post offices in each county, by year, from 1792 to date. This project is well along the road to completion.

Two publications were printed and offered for sale in the past year. Both the Federal Post Office list (pocket edition) and the revised manuscript post office book have met with a warm reception, as can be seem from the account of sales in the Treasurer's report. A supplement to the manuscript book was distributed in March, the second supplement to the large Federal Post Office book is ready for printing.

Only one issue of the postal history journal was issued during the year. The difficulty of publication lies not with funds or editorial effort, it lies squarely on the lack of material.

Emma Koberg has compiled an interesting list of the members by area which can be summarized briefly here. In the New York Metropolitan area, including locations within easy travel distance of New York, are 26 members. In the area central to mid-upstate are 27 members. Within easy distance of Rochester are 23 members. None of these numbers are duplicating, with some overlap it should be very easy to have a well-attended regional meeting in the three locations.
