Lee DeGraff announced with regret he would be unable to hold the usual September picnic at his camp.


Prior to adjournment it was announced the next regular meeting would be held at the Ranch Restaurant September 15, 1974.

QUAKER POSTMARKS

There were many Quaker settlements in New York State. The Town of Farmington in Ontario County was such a settlement. It was the custom of Friends to speak in a dialect called "Plain Language". Friends referred to days of the week as First Day (Sunday) Second Day (Monday) and on to the Seventh (Saturday) Likewise, months were known as First (January) Second (February) etc. For this reason markings from towns settled by Quakers shows date as 7mo27 for July 27 or 3mo20 for March 20. Examples are found on stampless covers. Usually manuscript markings.

DUAL ADDRESS IS AUTHORIZED

Postal regulations now permit showing both the Post Office box number and the street addresses on a mailing piece. However, the new "dual address" regulations provide that mail will be delivered to the address on the line immediately above that for the city, state and ZIP Code. The new procedures permits customers to identify their street address or physical location on business reply envelopes, advertising and coupons and yet have mail delivered directly to their post office box. Dual addressing will continue to be prohibited where a post office box number is not one of the addresses.

It is highly recommended that all box holders utilize this system to effect expeditious delivery of their mail.
