ALBANY REGIONAL MEETING:

The regional meeting in Albany on March 16th was again hosted by Nettie and Bill Seifert. The exact count was not taken, but attendance was larger than the count of 14 in February. A feature of the gathering was the number of members from the Capital District who turned out for the first time. There was plenty of material to look through, provided by Bob Harris, Bob Waite, Doc. Moore and others. This was an afternoon of good fellowship, with buying, selling, trading and exchanging collecting experiences.

INTERPHIL '76:

Interest in this important international exhibition is beginning to show. While still only in the preliminary stages, applications for frame space and dealers booths are passing through the hands of the regional representatives. This is the screening process, to assure that the central committees are not loaded down with applications which have no place in an International.

Another of the assignments given the representative is promoting attendance at the show, which will be held in Philadelphia, May 29 to June 6, 1976. We are anxious to know if there is any interest Upstate in a chartered bus trip to the exhibition. If so, it is likely the ESPHS will sponsor one or more trips, to leave on a Friday afternoon and return on a Sunday afternoon on one or both weekends.

Cost would include round-trip fare and two night in a motel or hotel, with transportation each day to the Philadelphia Civic Center if we are domiciled further than walking distance. It would be the standard type excursion, with reservations required, deposit with initial reservation, cancellation right up to a certain day before departure, etc.

The fact we are looking for is the degree of interest. If a reasonable number respond favorably we will know better if we can fill one bus, more than one or none at all. It is probable a number of wives and non-collectors would like to join us - all are welcome. There will be plenty of non-philatelic activity in Philadelphia during Bicentennial 1976.

We expect to bring this matter to the floor at the Annual Meeting May 4.

INFORMATION PLEASE:

Following up on the short research article regarding the so-called "bootleg" letter in the February Bulletin, we are looking for information. The last issue of Excelsior (November 1974) told of the $1\frac{1}{2}\phi$ war rate $(1\phi + 50\%)$ on drop mail processed in Albany, N.Y. The question arose, was this a quirk of interpretation of the PL&R in Albany and perhaps one or two other offices, or was it universal?

It would be extremely helpful if our members looked through their covers mailed between February 1, 1815 to March 31, 1816 for a drop letter. Which rate does it carry - the $1\frac{1}{2}\phi$ war rate or the regular 1ϕ rate suggested by the letter of the PMG to the postmaster at Hudson, N.Y.

The date must be precise and a Xerox would be appreciated if possible. Should you have such information please write to Cal Hahn, 127 W. 56th St., New York, N.Y. 10019.
