QUESTIONS and ANSWERS by Robert Dalton Harris

This question was submitted by Glen Estus. He has one cover dated 1883 and another 1890, directed to New York City in care of the Ladies Window, and wants to know the purpose and significance of the inscription.

The answer is an interesting one. In July 1975 "The Collectors Philatelist" reprinted an article on the New York Post Office from the May 1878 issue of Scribner's Magazine. The article states that a Post Office opened at the southern end of City Hall Park where Park Row and Broadway joined. A lobby floor plan of the building shows general delivery windows on the Park Row side "13 and 14 general delivery- Ladies Window; 15 and 16 general delivery- Gentlemen's Window".

In 1949 under APS auspices, Winthrop Boggs authored "Ten Decades Ago (1840-1850) A Study of the Work of Rawdon, Wright, Hatch, and Edson of New York City to which is added Sundry comments, and articles of interest illuminating the scene of the time". Among the sundries Boggs reproduced an article from Harper's New Monthly Magazine for October 1871 which said that the Ladies Window at the Dutch Church Post Office (which preceded the City Hall Park Office) was embellished with a sign arching the wicket reading "EXCLUSIVELY FOR LADIES". The text of the Scribner article rhapodized:

"The ladies window is especially a center for observation; and the appearance of the sex dressed in gay colors and wreathed in smiles lightens up the otherwise care-worn, pellmell, rushing, and somber-looking crowd. Here the young lady of the period contrasts with the old crone whose undutiful son is "off to sea". The widow in her weeds throws sly glances at the dashing clerk; her hopefulness of the future contrasting strongly with the face of the suffering wife, who sad and discontented turns abruptly away because her absent spouse "had failed to write".

No doubt, several reasons supported the segregation of ladies and gentlemen at the active post office of New York. Not the least of these was probably to insulate the ladies from the unwanted intimacies of standing in line with strange men. Too, for a gentleman etiquette was quite explicit with respect to the opposite sex— a true gentleman would have felt obliged to stand aside to let the female move into his place. In an office as active as New York's, he might never have been able to get his mail.

Now we no longer have separate windows for men and women at the post office. Respect for the female has decayed to the point that the traditional female roles seem so poorly compensated that they are interpreted as exploitation. The present female struggle seems designed to reestablish the individual sense of value that once was guaranteed by etiquette and manifested in separate windows at the New York Post Office.

The following proposed changes have been submitted by members. Each change has been researched in as much detail as possible with the data available. If any member has any information which is at variance with that suggested, please send same to Emma Koberg before Nov. 30, 1975. If no further information is received, the changes will be published as Supplement No. 4 in January 1976.

- Barnevelt --- Oneida Cty- In postal records and New York maps spelling is barnveld. Should be changed in Fed P O
- Benson Mines -- St. Lawrence Not in alpha. Should be included with *.
- Blinham---- Delaware Cty- Not in Fed but data is in Kaiser's P O of N Y. Should be included.
- Brown Station Ulster Cty- In alpha as Browns Station. Should be corrected.
- Canada Lake--- FultonCty --Disc 11-15-73 in accordance with Postal Bulletin 20955. Change should be made.
- Cold Water --- Monroe In county list as Coldwater. Not in alpha Correction should be made.
- Dansville --- Livingston Cty- Listed in Fed as <u>Danville</u>. Should be changed.
- Fort Totten--- Queens Cty--Not in alpha. Should be included.
- Franklinville -- Cattaragus Cty in alpha with *. Active accordance with Postal Records. Should be changed.
- Garbutt---- Monroe Cty-In alpha as Garbut. All records show spelling as Garbutt. Should be corrected.
- Hawkeye- -- Clinton- Fed disc 1933. Postal Bulletin 20959 indicates disc 6-30-73. Should be changed.
- Head of Delaware-Delaware Cty- Not in Fed but in Kaiser's P O of N Y . Should be included in Fed.
- Higgins Bay- HamiltonCty- Disc in 1962 in Fed. Postal Bulletin 20966 gives disc as 12-31-73. Should be changed.

Taughannock Falls- Tompkins- Not in Fed. Records in National Archives-

Est June 19, 1874 P M Roswell Wilcox Disc Nov 15, 1917

This office should be included in Fed P O

Union Hill---- Monroe Cty - Fed as Union Hall. Postal and county records as Union Hill. Change should be made.

West Webster---- Monroe- Fed disc 1958. Post Mark for 1961. In accordance with 1973 Postal Records office active. Change should be made.
