The recent issue of the Chronicle, journal of the U.S. Philatelic Classics Society, carried the announcement of Ken de Lisle being appointed section editor for a new Pre-Stamp and Stampless Section for that magazine, which is the only stamp publication devoted exclusively to 19th Century stamps and postal history. This new section extends the coverage back in time some 100 to 200 years. If you are not a member of this organization, ask Ken for details.

APS Affiliate Chairperson Barbara deViolini called a meeting of the Unit and Affiliate representatives at San Francisco. We are fortunate that Bill Bauer was able to take time from other important duties to attend and file the following report:

At the request of President Seifert, I attended the joint meeting of the A.P.S. Units and Affiliates during the A.P.S. Convention at San Francisco.

The purpose of the meeting was to clear up some misunderstandings and to establish better communications between the Units and the A.P.S. Barbara deViolini, as Affiliate committee chairman of the A.P.S. represented the Society and expressed thanks for being on the mailing list of so many of the Units. However, she also advised those present that the journals are of but a little help in publicizing affiliate activity as most are received after the fact. She should be advised well in advance of meetings, conventions, special publications and other activities if publicity in the American Philatelist is desired.

It was reported that, by action of the A.P.S. Board of Directors, only A.P.S. Affiliates will be permitted to sponsor seminars and/or meetings at future A.P.S. annual conventions. (The seminars at the San Francisco meeting were well attended). Requests for space to hold a seminar at an A.P.S. Convention should be directed to Jack Willard, Special Activities Director, 1025 Monroe Street, Denver, Colorado 80206.

It was pointed out that affiliates (and units) may, by sending to State College the name and APS number of new members listed in the American Philatelist, obtain the individual's address for solicitation for Unit membership.

It was suggested that each Unit should provide the A.P.S. Central Office with a supply of (their own) unit membership applications to be used as replies for inquiries received there. Hopefully, each unit will also send copies of its bulletin or journal to the American Philatelic Research Library.

There was some discussion from the participants concerning the possibility of the A.P.S. Central Office providing some help in the preparation of Unit mailing lists and membership lists. Such an idea was considered several years back but foundered on the questions of cost and effort required. Perhaps, now that the A.P.S. has adopted a computer system for its own membership processing, such a plan could be considered.
