

NOTES ON THE CRUM ELBOW POST OFFICE by: Roy Ahlquist

The information in this article will not make any definitive study. The intent is to share some information which has been gathered, to speculate on a few thoughts which seem to have no definite answer, and to share this information and speculation with you, the reader.

The Crum Elgow Post Office is one of the five discontinued post offices in the town(ship) of Hyde Park, Dutchess County. For the greater portion of its existence, it serviced a local area running approximately eight miles north-south, and about half that east-west. During its course of its sixty four years, it seems to have had six locations (see map), of which three or four locations were in

R. F. D. PENCIL CANCELS

A very interesting and not too costly type of collection is the use of indelebile pencil markings on mail picked up and delivered on R.F.D. routes without being returned to the post office.

A variety of markings are seen. Some include the name of the town, the words R.F.D., but most are just lines on the stamps similar to the present ball point scratches on mail which misses the canceller.

Most examples are found on post cards of the period. Finding a manuscript on a letter is quite challenging as people living that close together didn't write each other.



structures still standing. The first two postmasters were Quakers; however, I do not know if numeral markings were used as was common with Quakers. When the post office was first established, we were in the stampless period. It remained in continuous operation until the days of rural free delivery when it was discontinued, September 30, 1903.

Israel Marshall, a farmer, became the first postmaster on July 14, 1839. The location was his home, a house constructed in the Greek Revival style. The house is still standing and is a private residence. Marshall was thirty three years old when he assumed the appointment, and he held it for twenty two years. is probable that the post office at this date serviced not only the people who lived in the immediate area, but also the farmers who would pass this way taking produce to the Hudson River at either Hyde Park or Poughkeepsie. It is reputed that many farmers from the east into Connecticut chose this way in order to avoid the Dutchess Turnpike which was a toll road until as late as 1893. Israel Marshall died July 13, 1873.

Israel Marshall was a practicing Quaker. He remained postmaster until July 15, 1861. In addition, his replacement, Ben-

jamin Carpenter, was a Quaker, and he held the appointment until July 10, 1866. It is, therefore, very probable that either Marshall or Car penter used a dial and that the dial used numbers in place of words for the days and months as was the Quaker tradition. Unfortunately, I do not have a single cover with a Crum Elbow strike, nor have I seen any. Sampson does not even list Crum Elbow, and our own publication, the 1972 Provisional Listing of Manuscript Markings, indicates a Crown Elbow, 1847; however, this must be a typo for Crum Elbow. This would indicate that as of that date no canceller was in use (or it was misplaced that day).

While speculating along this line, Israel Marshall's father, Zacheus Marshall was a landholder in 1770. He and another individual purchased a two acre lot for the Society of Friends (Quakers), and on that parcel the present Crum Elbow Meeting house sits today. That meeting house was constructed because there was a church conflict at the meeting house which existed on the Crum Elbow Creek along the eastern branch. This was also known as the Crum Elbow Meeting House to differentiate it from the one located in what is today Stanfordville (Post Office making "Friends Meeting House"). The disagreement was over the theology of John Hicks. As a result, the group split. It is reasonable that the splinter group continued to use the name Crum Elbow Meeting House, and from that

may have been derived the name of the community. This would possibly explain the slight distance difference from the creek, and the origin of the community name. In addition, it is further indication that a Quaker marking was probably used at one time. Can anyone help?

John Stringham assumed the postmastership June 11, 1866. The post office was relocated about two miles north on Quaker Lane. The house is still standing and is a private residence (assuming I have the correct house.) The location is just about across from the Meeting House and is so marked on the 1867 Biers map. John Stringham operated a small general store which was a part of his house.

On November 16, 1882, Benjamin Shelden became the postmaster. The location was across from the Stringham store. It is the first house north of the Meeting House cemetery, and I am assuming that he operated the post office from his home. He held the postmaster position for only three months.

Sarah Sherwood was appointed postmaster February 20, 1883, and held the position until June 1, 1885. I have not been able to locate where she maintained the post office. The same is true for the next two postmasters, Lincoln (6/2/85-6/5/90), and Augusta VandeWater (6/6/90-2/27/94).

It is possible that the VandeWaters operated the post office on the East Park Road, on the north side just west of Quaker Lane. The only indication that I have that might have been there is local recall that an abandoned post office was located there in the 1920's, and that the building burned, reputedly by some boys.

The last location placed the post office on Mud City Road, now called Cardinal Drive. Henry Van Wagner was the post-master, receiving his appointment February 28, 1894. The post office remained in this location for seven years when it was discontinued, September 30, 1903

As an aside, Mud City Road was named in the Eighteenth century because of the style of house which had been built here, mud walls and thatched roofs. The name was changed some ten years ago because it lacked dignity.

Well, there it is...all that I have to share with you. If you can add any information on Crum Elbow Post Office, I would be very appreciative.

RFD PENCIL CANCELS (cont)

Since most rural people didn't have phones or autos they sent short messages or greetings which were delivered the same day since the mail wasn't returned to the post office for redelivery.

Here is a typical post card message:
"Dear father and mother, If you have any
new potatoes to sell dig up a half a bushel and we will be up after them tonight
after supper."

Although some offices had rubber stamp markings most of the carriers used the indelible registration pencil to cancel the stamp. Many locations are hard to identify as they were addressed R.D. #1, en route or Box 41.

For just two cents - a penny for the stamp and a penny for the card written appointments could be made for the same day. No need for dial phone or \$1.39 gasoline.

Today for twelve cents plus a ten cent card plus automation a person living on the same route can expect delivery in two or three days. Such is progress...

Order No. 875 for cancelling all rural mail improves accounting methods

The Postmaster General's Order No. 875, for the compulsory postal marking of all rural route mail collected, effective August 1, 1900, had supplementary sections concerning rates, recording and cancelling details for the special attention of, and action by, all rural route carriers.

It soon appeared that the new cancellation devices were not available that promptly, as verified by the earliest recorded marking being at the end of August, five weeks later!

After all, it takes time to make over 1300 devices and distribute them to the rural offices involved - and many more routes were scheduled for establishment after that date.

ORDER OF THE POSTMASTER GENERAL.

Office of Postmaster General, Washington, D. C., July 28, 1990. Order No. 875.

First. That on and after August 1, 1900, the "drop letter" or one cent rate of postage will not apply within rural free delivery limits. The two cent per onnce rate will be exacted within such delivery upon all first-class matter except postal cards.

Second. That the introduction of rural free delivery will not increase or otherwise modify the present rate of postage on second-class matter.


Third. That rural free delivery carriers will not bring to the post office mail matter, collected by them, which may be delivered on their routes before completing their trips.

Fourth. That stamps upon mail matter collected by rural free delivery carriers, including those on matter delivered en route as directed in Section 3, will be cancelled by them and reported to the postmaster, who will derive the benefit of the cancellation if the office is Fourth Class.

Fifth. That until suitable rubber canceling stamps can be supplied by the Department, rural free delivery letter carriers will cancel stamps with the indelible pencils recently furnished them for use in registering letters.


