# NEW YORK SPRAY-ON POSTMARKS (PART I) BY TERENCE HINES

The first use in the United States of an ink jet printer to apply a postmark took place in Stamford, CT in August, 1989. Since then the use of what have come to be called spray-on postmarks has greatly increased, as has collector interest in these markings. The spray-on postmarks were instituted by the U.S. Postal Service (USPS) to take care of the problem of "stale" meter dates. These are dates in meter imprints that are earlier than the actual date of the mailing. Thus, it appears to the addressee that the mail piece was mailed before it actually was and that it took longer to be delivered than it actually did. The USPS gets the undeserved blame for the "late" delivery in such cases.

The spray-on postmarks are actually applied by ink jet printers interfaced with Multi-Line Optical Character Readers (MLOCR), devices used to read addresses on envelopes. It now appears that some ink jet printers have been attached to single line OCRs. This means that spray-on postmarks may begin to appear from mail processing centers that are too small to have MLOCRs, but may have SLOCRs.

While the intent of the USPS in creating the sprayon postmarks was to correct stale meter dates, these postmarks are often seen on mail bearing postage stamps. This has led to some speculation that the USPS plans to replace familiar cancels with spray-on cancels. This speculation is unfounded. First, the spray-on postmarks make terrible cancels for postage stamps. Second, the reason they are found on stamps is that the ink jet printers are often left running after batches of pure metered mail have been processed.

Spray-on postmarks have been reported from nine locations in New York State. Seven are from known cities and two are markings that, for whatever reason, do not include any city name. The listing that follows includes all New York spray-on postmarks that I have seen. Since the exact text of a postmark can apparently be easily changed by the operator of the ink jet printer, there are quite a few varieties that differ only slightly from one another. Slight differences such as the presence or absence of a period or comma do, it seems to me, constitute collectable varieties and are separately listed. In the following listing I have transcribed the text of each marking exactly, including spacing. Thus, one marking that includes "OCR # 11" is considered different from one that includes "OCR #11". The fact that the exact text of these markings can be so easily changed has led to the use

## PRESIDENT'S CORNER

The fall meeting at Sidney is over. I thought it was great, but there were many who did not share my view. The people at CINCOPEX liked having us and expressed a hope that we would come back often. We will be back with CINCOPEX at Rome for our twenty-fifth anniversary meeting. After that event, however, we have no commitments

I spoke to the President of the Federation of Central New York Stamp Clubs, and through Maris we will investigate some sort of membership or affiliation. We will also look into our relationship with CINCOPEX. I would like also to be more active with ROPEX, to give us more visibility at the western end of the state. Steve Matte has promised to do something to make us more visible in northern New York.

Mr. Kline has resigned as a Director and Mr. Hulbert will not run again. The latter likes Florida and plans to spend much of the year there. He feels that a Director should be a full-time resident of the state.

The Board of Directors and those voting at the regular membership meeting agreed to full funding for the magazine to be issued for our twenty-fifth anniversary. It should be out in September 1992. I had hoped to discuss a new budgeting process, but time did not allow for this. It probably needs much thought and I will work closely with Maris to try to come up with something. The big problem is contingency funding and the funding of publications.

In this regard, it was tentatively decided to add two new classes of membership to the Society, Sponsors and Patrons, naturally at higher dues. The extra money would be used to fund publications. There would be advantages in terms of discounts on publications. Much has to be worked out, and finalization is years off.

We did not discuss the matter of every Director having a specific assignment in re various functions of the Society. Again, time did not permit us to cover everything I would have liked. However, everyone had a chance to speak out on the topics covered, and most of those present took full advantage of the opportunity. Maris Tirums will give you a full account of the meeting in his Meeting Minutes which will be published in the new Society Newsletter coming out of Albany. I strongly suggest that you read them to see what, if anything, I omitted.

On a more personal level, I found the banquet a delight. The people were outgoing and most friendly, and the emcees were very funny. It was a lot more fun than the formal banquet at Stampshow '91.

I particularly liked the chance to see exhibits by members of the Society. Bill Hart got the APS gold for his exhibit of twentieth century cancellations. The covers were not expensive and were brilliantly chosen and displayed. Bill is terrifically well organized. He spends a fifth of what I spend on his exhibits and gets twenty times the results. ### **NOTES**

These figures do not factor in a major consideration - the number of entries which might have been received had the ESPHS not actively recruited its members to support the show. Incidentally, CINCOPEX'91 did have to turn down entries received in September and October due to lack of floor space. This fact will be given due weight in planning the Rome show.

The list includes the following: Bardonia, Bear Mountain, Blauvelt, Congers, Garnerville, Haverstraw, Hillburn, Monsey, Nanuet, New City, Nyack, Orangeburg, Palisades, Pearl Rivers, Piermont, Pomona, Rockland Lake, Sloatsburg, Sparkhill, Spring Valley, Stony Point, Suffern, Tallman, Tappan, Theills, Tompkins Cove, Valley Cottage, West Haverstraw and West Nyack. At the date of issue there were 29 post offices in Rockland County. Therefore the above collection is one envelope from each. Most of them were machine cancelled.

exactly what he needs and that's what he purchases. His preparation of lists of needed material is awesome. I wish I had his self-discipline.

John Lange had a number of exhibits of very high caliber. He won almost everything else in sight--three awards. I really liked his page layouts. However, I was told that under APS rules, picture pages are frowned upon, and Mr. Lange used many maps to enhance his covers. CINCOPEX rules are different and this was a CINCOPEX show.

At the N.Y. Collectors Club and at Stampshow '91 I saw first rate exhibits, but often felt that the results depended on the wealth of the exhibitor. Some of the exhibits must have represented hundreds of thousands of dollars. CINCOPEX rules discount the value of the material displayed, giving it only five percent of the exhibit scoring. There is a lot to be said for this, especially if one is not wealthy. This is not to say that all national exhibits depend on the wealth of the exhibitors. Some depend on the imagination of the owners, which is why Mr. Hart does so well at a national level.

Modern postal history is a step in the direction of the use of imagination and effort as opposed to the use of money. I think it is the wave of the future. Most of the material is inexpensive if obtained in a timely manner. However, you have to know what you want to collect and act to obtain it at the post office and through the mail. Even if you have to purchase some items, they should be inexpensive. In ten years, what is cheap today could become quite dear.

Lastly, attendance at the show was up to that at Utica. We will try to make provision so that all the dealers who sell at Utica will be given the same opportunity in our meeting rooms at CINCOPEX shows. They had the opportunity at Sidney, but we were remiss in getting out the information.

There was structural damage to Karrat's Restaurant. However, I have written assurance from Doctor Joseph Rowbottom III that the restaurant will be repaired in ample time for us to hold our May meeting there. Maris will give you the exact date.

Elections for "Class of 1992" Directors are coming up. Please write to me if you would like to be considered for a position.

of some varieties for only a single day. These stand to be the rarities of the early history of spray-on postmarks.

Since this listing includes only markings I have seen, with the exception of several Albany markings to be discussed below, I must assume that there are many other markings that I have not seen, but which other readers have seen. Please report any additions to this listing to the editor.

(Editors' Note: Professor Hines expected this article to be run in its entirety. This proved to be impossible due to space and time constraints resulting from his many illustrations. This was explained to him and he reluctantly agreed to our printing his article in installments.

Unfortunately, after a general introduction, Professor Hines discusses in detail a specific Westchester County cancel which is not illustrated. (Actually part of the point was that the cancel was in orange which, of course, we cannot reproduce.) He discusses some other characteristics of the Westchester County sprayons which will be illustrated in a later installment. He also discusses a problem in reference to Albany cancels which will also be included in a later installment.

The material that we have included in this installment is covered by the discussion on Page 1 which covers the background of these postmarks. Inasmuch as the spray-on postmarks are still evolving, new material will constantly coming to light and will have to be discussed on an ongoing basis.


In order to increase the clarity of the illustrations some have been enlarged. Obviously the measurements given, which are for the actual spray-on postmarks, are not necessarily correct for the illustrations. Please keep this in mind when making comparisons. Furthermore the originals have been enlarged by different percentages. Thus two postmarks which here appear to be the same size may be of significantly different dimensions in the original.

This study of spray-on postmarks will be an ongoing project of Professor Hines. Your contributions to it would be most appreciated by the author and editor. Updates will be printed as called for.)



# THE STORY OF THE LAST FLAG MACHINE, SIDNEY CENTER, N.Y. BY HARRY TABER

The story of the last of these machines starts in Sidney, N.Y. when three postal clerks, Nellie Bartley, her brother Frank and Fred Gail decided jointly to purchase a machine. The P.O.D. was deluged by orders and made the concession of allowing postal employees to buy a machine. The <u>Delaware County Enterprise</u>, a weekly paper of Sidney Center, said in its April 12, 1911 issue that "A hand cancelling machine with a capacity of 250 letters a minute has been installed in the P.O. It is a greatly appreciated labor saving device". Below is an early example:





Years passed an each one saw fewer machines in operation. In 1924, 1925, and 1926 the clerks were unable to obtain type for the yeardate from the P.O.D. and were forced to buy it from the local printer. This produced a distinct variety soon noticed by collectors. It also made a headache in the P.O. as the new type required shimming to fit and a hurried job produced examples like those below:




In 1925 the clerks decided to try a smaller type in the date. However, this small year date had a tendency to load up with ink under constant use and was finally discarded and replaced with a larger date.






The flag machine was sold in 1928 to the P.M. in Sidney Center, who was an enthusiastic collector. He succeeded in obtaining a new dial and placed the machine in use. Eventually, as the other machines were out, it became the last flag in use. The P.O.D. finally ordered that it be retired and May 27, 1941 was the last day of regular use.




## LAST FLAG MACHINE, SIDNEY CENTER, N.Y.

## WILLIAM GARRATT, POSTMASTER OF GARRATTSVILLE, N.Y. BY CHARLES EDWARDS

William Garratt's father, Robert Garratt, emigrated to New York State from England in the mid 1700's. The Garratt family came from the same parish in England as the Tunnicliffs, and it was only natural that Robert followed his friend as a pioneer settler to the New England Settlements of Otsego County. While Robert Garratt settled in the Burlington area, his sons, John and William, established residence just north of what became the village of Garrattsville, N.Y., named after their family.

In 1778, John Garratt and wife were taken prisoner by raiding Indians and held captive for seven years. Knowing that such raiding parties were a threat and hearing gunfire to the north of their home, they became aware that Indians were approaching. Mrs. Garratt thereupon hid the family silverware under an inverted pig trough and their clock under the garden fence. They attempted to hide in a bowl-shaped hollow nearby, but were discovered and taken captive. Upon their return in 1785, although their clearing was now overgrown with brush and weeds, they found both the silverware and clock where originally hidden.

William Garratt built his cabin approximately one mile north of the village and became the pioneer merchant of Garrattsville, having built a store there in 1795. At this time, he was also clerk of the Militia Society of Col. David Bates' Regiment per his signature on a notice of meeting dated June 1, 1795. It is recorded that in 1802 William Garratt paid \$5.00 for a liquor license.

The village of Garrattsville is in the Butternuts Valley, the Township of New Lisbon, Otsego County, N.Y. Originally, it was in the Township of Otsego (1791), then in the Township of Burlington (1792), in the Township of Pittsfield (1797) and, finally, on April 6, 1806 became a part of the newly organized Township of Lisborn. Two years later the name of the Township was amended to New Lisbon. The first town meeting was held March 3, 1807 and William Garratt was elected Town Supervisor, a post he held for seven successive years.

Upon establishment of a post office in Garrattsville under date of March 3, 1809, William was appointed Postmaster. Without question, the post office was located in his store. He served as Postmaster for many years and he was still listed as such in the 1825 Postal Directory.

It is recorded that in 1820 Major William Garratt installed in his store the first stove (an open grated Franklin) seen in Garrattsville. The cover illustrated for this article bears a dateline of May 10, 1822 and is to a supplier of merchandise for his mercantile establishment. Unquestionably, his Franklin stove was still in operation at this date.

From the 1824 Gazetteer, State of New York, is the following: "the Garrattsville Post Office is on the road that leads down the Butternuts Creek from Burlington, through the town and thence to Oxford, N.Y." This was originally serviced by a postal carrier once a week and was known as "Post route #48". Later, mail service was provided three times weekly over the same route by stage coach. It is interesting to note that the stage had to announce arrival of mail by sounding a Post Horn eighty rods from the Post Office. Regulations of that date only permitted seven minutes for the delivery and acceptance of mail. In the late 1790's, mail traveled from Cooperstown to Burlington. From there it either continued on westward on the Ithaca Post Route or headed down the Butternuts Valley crossing to the Unadilla Valley at Mt. Upton, then through Guilford to Oxford. Like Cooperstown, the Oxford Post Office was an early one, having been established in 1796.

To complete the personal history of this first postmaster, the early records confirm that he became an influential and prominent figure locally and in the county. In the process, he became a large landowner and fairly wealthy for the times. Sometime prior to 1835 he established a cotton factory in Garrattsville. This manufacturing operation became a financial disaster and plunged him into deep debt. Unable to meet all of his obligations, he abandoned his holdings in the area and with his wife, son and daughter, went to Canada, never to return. By 1855 there was no one by the name of Garratt living in New Lisbon Township, a sad ending for a pioneer family who helped expand the frontier of New York State.

However, a monument stands to this day on grounds of the old homestead north of the village, erected by Mrs. William Garratt in memory of her father-in-law, Robert Garratt, and John Johnson, another early settler, whose daughter married John Garratt.

# METROPOLITAN AIR POST SOCIETY By Robert S. Miller Sr.

Back in the exciting days when aircraft were still in the development stage, the average person did not fly. Most could not afford it. Even if they could they did not trust these new contraptions that seemed to defy logic. In spite of numerous accidents and the death of many gallant men, aviation enthusiasts never lost faith. New and better aircraft were built, instruments were improved, airways were established, and engines improved. In time, air transport was here to stay. The first commercial use they were put to was for the carriage of mail.

Many came to the airports where the mail flights took place, and among them were aero philatelists who wanted souvenir covers that were carried on these flights. By the time World War II broke out, air mail collecting had become an important part of philately. Gerhardt Kaufmann, Gus Lancaster, Bill Schneider, Sam Goldsticker and Lou Fischbach among others in the New York City area decided that they would form a club that would be devoted to the creation of covers that would be used for important air mail events. Some examples are shown. In April 1942, the Metropolitan Air Cover Club was established. This club met in the Hotel New Yorker and before long attracted many devotees from the New York metropolitan area. The club grew in size and counted among its members some of the most important aero philatelists of the time.

An idea of the wide scope of interests pursued by members can be ascertained from the 1950 Directory which we cite at the bottom of the previous column.

Meetings featured guest speakers, some of whom were Admiral Jesse Johnson, Lieut. Schildhauer, Clara Adams, to name a few. Meetings also included the exchange of covers and an auction. Usually after the meeting ended many of the members would gather at one of the nearby watering spots in Manhattan where they continued their meeting until the early morning hours. By 1950 no less than 360 collectors had joined the Metropolitan Air Cover Club.

When Gus Lancaster passed away it was decided that an annual award would be presented each year in his honor to the aero philatelist who, in the opinion of the judges, had made valuable contributions to the hobby. Some of the former recipients were the following: Dan Barber, Michigan; Fred Wellman, Florida; Michael Stone, New York; John Johnson, Jr., Connecticut; Ken Sanford, Geneva, Switzerland; Sam Goldsticker, New Jersey; Mike Codd, New York. The award is presented in conjunction with the INTERPEX show in New York City. The Metropolitan Air Post Society participates by providing speakers for the seminars held there.

The club does not hold regular scheduled meetings. However, meetings are held in the New York Collectors Club in January and at INTERPEX and NATIONAL shows held annually in March and October in New York. Members are kept in touch through the club journal. The *Bulletin*, a fourteen page quarterly publication, features air mail articles about material that is not normally found in catalogs. Questions and answers assist members to identify unknown items. The annual picnic, usually held in July or August at the home of a member, is an eagerly awaited event. Membership of approximately one hundred includes collectors from many parts of the United States and several from foreign countries. The dues of five dollars annually includes the *Bulletin*.

Nineteen ninety-two will mark the fiftieth anniversary of the club which originally was called the Metropolitan Air Cover Club and today is known as the Metropolitan Air Post Society. Plans are under way to celebrate the fiftieth anniversary in conjunction with NOJEX, the show of the North Jersey Federation of Stamp Clubs, which will be held at the Meadowlands Hilton over the Memorial Day weekend in 1992. Air mail exhibits and seminars by MAPS members will be featured at NOJEX. Other special events are being planned. Members and former members are invited to attend the banquet, which will be a special feature of the meeting.








## OF INTEREST: Oswego Machine Cancels

# MINUTES OF THE ANNUAL MEETING OF THE EMPIRE STATE POSTAL HISTORY SOCIETY OF MAY 5, 1991

President Hart convened the 24th annual meeting of the ESPHS at 1:35 P.M. at Karrat's Restaurant in New Hartford, N.Y. Approximately 20 members and guests were present.

The Secretary was called on to give a report. Members were advised that the Society has experienced rapid growth during the previous several years. The 1990-91 year started with 222 members and ended with 243. Credit for recruiting was given to President Hart and Vice-President M. Margulis.

The President explained how he had assigned awards duties to Messrs. Johnson, Ellman, and Parsons to handle in their respective geographic areas. The results were mixed, as only the central NYS area staged shows where ESPHS awards were used.

Al Parsons reported on the success of ESPHS members at ROPEX. Lou Call and Nate Calkins both received vermeil awards. It was noted that a book on western NY postal history was available from Nate Calkins. Interested persons should contact Nate directly.

Upcoming shows were announced: SYRAPEX will be held in Syracuse on September 14-15, 1991; CINCOPEX will be in Sidney on October 12-13, 1991; and STEPEX will occur in Elmira on October 18-19, 1991. Only STEPEX of the three is not an open competitive show. STEPEX '90 had no fewer than five exhibits on NYS postal history material.

Efforts to have ROPEX list the ESPHS award failed for unknown reasons. It was suggested that we should contact Richard Kase about this in future years.

Vice-President Margulis stated that more members are needed to work at recruiting more members.

Jack Haefeli reported on publications activities. He credited Martin and David Margulis with producing the *Bulletin* during the past year.

David Proulx's success in publishing the NYS County and Postmaster Cancellation book was noted. The Otsego County book is still being worked on.

The Treasurer reported that the Society ended the 1990-91 year with a \$795.06 decrease in funds. An itemized account of the revenues and expenditures was given. A motion was made, seconded, and passed to accept the Treasurer's report.

Questions were raised about the advisability of the Society to have the amount of money it has. This was answered by pointing out that the interest income has enabled the Society to function and to keep the dues at a constant \$5 level for so long.

The expense of the *Bulletin* was questioned. The Treasurer gave a finer itemization of *Bulletin* expenses. The Editor defended the costs.

Gerald Wiley reported on plans for the Society's 25th Anniversary in 1992. Several possible features of this celebration include participation at a local stamp show where the Society could meet, exhibit and celebrate its anniversary. A banquet has been considered. George Bernadt said this would succeed if members came and stayed overnight. Emma Koberg suggested that a luncheon might be better than an evening banquet.

Gerald explained that Lou Call, Charlie Edwards and Ken

deLisle were also on the 25th Anniversary committee.

George Bernadt opposed having an auction at the celebration. Lou Call and Dave Proulx said that many plans depend on the size and availability of the show venue.

Ken deLisle related that the Society is considering asking the Utica S.C., host of CINCOPEX '92, if we couldn't participate in the show for our anniversary. The first step toward making plans will be to hold our next (October) meeting at CINCOPEX '91 in Sidney. Toward this, we have guaranteed CINCOPEX fifty frames of exhibits. Details of the committee's progress will be provided in the *Bulletin* 

Editor Margulis said that special editions of the *Bulletin* may be needed to give timely information about the anniversary activities and plans.

Auction Manager Bernadt made a plea for suitable auction material. Members are urged to send George their excess material so that our highly successful sales may continue.

A motion was made, seconded, and passed to hold the 1991 semiannual meeting at CINCOPEX in Sidney, N.Y. on Sunday, October 13, 1991. This will be at the Masonic Temple in Sidney.

John Cali of the nomination committee reported on the slate of candidates standing for election. They are:

A motion was passed for the Secretary to cast a single vote in favor of the slate. The nominees were duly elected.

Emma Koberg posed the question of whether the by-laws needed change with respect to nominations. President Hart said he felt the current process was somewhat unclear. He felt that the 9 directors-at-large are not as effective as 6 of the 9 directors representing specific regions would be. Communication to the members would be better with such a set-up. No further discussion of these matters ensued.

Emma Koberg took the floor to present a Life Membership to Charlie Sweeting. Her statement described Charlie's role in founding the ESPHS and his contributions over the years. Charlie was not present for health reasons, but the whole membership expressed its approval of the Life Membership and conveys its congratulations. Bill Seifert urged everyone to support any regional meetings that are scheduled in their proximity. Al Parsons said he felt another central NYS meeting should be attempted.

President-elect Margulis thanked Bill Hart for his work for the Society. He spoke of plans to implement new ideas and of the need for more members to become involved.

The Treasurer advised the members that a draft budget of 1991-92 was prepared, but that new information gained that day called for revisions. Thus, the budget was not presented for formal approval. The members present gave outgoing President Hart an ovation, whereupon the meeting was adjourned at 2:51 P.M.

Before submitting a nomination to the secretary, you must verify with the nominee that he is willing to be elected and will serve if voted in. Any member who receives three or more nominations will automatically be placed on the ballot.

The President will, with the counsel of other members, strive to have at least three nominees available to fill the vacancies. Nominations from the members at large are in addition to the nominations that are expected to come from the President..
