## MANUSCRIPT POST OFFICES OF NEW YORK STATE

The ESPHS compiled extensive data on New York State manuscript postmarks, and published a book in 1984. This book is still in stock, and may be ordered from the Society for \$10 postpaid (see the list of ESPHS publications elsewhere in this BULLETIN).

After the "manuscript" book was published, many members compared their own covers with the information in the book, and the ESPHS received a fair amount of new information, mostly on previously unrecorded manuscript post offices and on earlier or later dates of usage than those listed in the book.

Two supplements in four installments of new data were subsequently published in the **ESPHS BULLETIN** - in the editions of April and August 1987 and Winter and Spring 1990.

This is to inform ESPHS members that the Society is still interested in collecting new information on New York State manuscripts, and that this information is being compiled by **Henry Chlanda**, PO Box 11-047, ALBANY, NY 12211.

Any member who comes across new manuscript data is urged to send it along to Henry. Photocopies of covers bearing new markings are especially useful. Eventually, an updated manuscript book will be prepared to reflect all the data we've accumulated in a single reference work.

## PRESIDENT'S MESSAGE

## Report on CINCOPEX 1992

The 1992 competitive exhibition and dealers' bourse was held at Rome, NY on October 17-18, hosted by the Fort Stanwix Stamp Club under the effective chairmanship of ESPHS member Dr John B Ludin, supported in no small way by long-time CINCOPEX booster Franklyn Rudd.

The Empire State Postal History Society celebrated its 25th Anniversary on October 17 with a luncheon and meeting at the Polish Home, site of the exhibit and bourse. These events will be reported separately.

Our participation in the exhibit took the majority of space and contributed to what was characterized as the highest quality material seen at CINCOPEX in many years. The jury, we were told, did not reach its decision on BEST IN SHOW OPEN until just minutes before the awards dinner. Fourteen of our members put their treasures up for viewing by their peers and the general public and a shot at the nice trophies.

CINCOPEX 1993 will be held at Utica, October 9-10, at the Oneida County Airport Sheraton Hotel. Although we might not participate as another society effort, individuals are encouraged to exhibit. The Empire State Postal History Society will offer its usual trophy for the best NYS postal history showing.

The 25th Anniversary Committee concludes its activities with this report. It has been a privilege and pleasure to serve in this capacity over the past two years.

## MINUTES of the Semi-Annual Meeting of the Empire State Postal History Society of October 17, 1992

In conjunction with the 25th anniversary of the E.S.P.H.S., the Society decided to hold its semi-annual meeting in Rome, NY at the site of CINCOPEX '92. As part of the anniversary observance, the Society solicited exhibits from its membership to be displayed at CINCOPEX, sponsored a number of awards for the exhibit at CINCOPEX, and arranged a luncheon for members and guests. CINCOPEX '92 was held at the Polish House in Rome. The show was put on by the Fort Stanwix Stamp Club of Rome, and consisted of about ten dealer tables and a competitive exhibit mounted in six page frames.

At noon, the luncheon attendees congregated in the downstairs banquet room at the Polish House. A hot buffet was served to about 30 attendees. Immediately following the luncheon, a meeting was convened and the business of the Society was dealt with.

The semi-annual meeting of the E.S.P.H.S. was called to order at 1:20 PM by President Margulis. He welcomed the members to Rome on the occasion of the Society's 25th anniversary. He then announced that he was not running for reelection as president, and that in fact, none of the three standing officers were running to be reelected. A slate of nominees was being assembled by Charles Edward's nominating committee.

Charlie Edwards then gave a brief report on the activities of the nominating committee. The December **BULLETIN** will contain a notice to the membership that nominations are open, and anyone wishing to run should see that three nominations are submitted by March 20, 1993. The committee has lined up nominees for all positions up for election except the president's post.

The Secretary distributed new up-dated rosters. Copies will be mailed either with the **BULLETIN** or **JOURNAL** to everyone not present and receiving a copy then and there.

Martin and David Margulis reported on the progress of publishing the next issue of the postal history **JOURNAL**. This edition is to be a special anniversary issue consisting of 60 plus pages. It has been delayed due to technical and personal factors, but should be ready before too much longer. The editor listed many of the interesting subjects that will be covered in this edition including NYC locals, NYS railroad post offices, and many others.

The editor indicated that he currently has enough material on hand for the next two years. As he was considering moving to a southern state in the near future, a new editor would have the benefit of these stock piled articles.

Pres. Margulis stated that current V.P. Bob Harris has indicated a willingness to assume the editor's job under specific terms. For \$1500, two editions of the **JOURNAL** of 32 pages each would be prepared on an annual basis. This raised some questions from the members which could not be answered without further clarification.

Ada Prill of Rochester was introduced as the exhibit chairman for ROPEX '93. She said that the exhibit at the next ROPEX was essentially full, but that she could set aside 25 frames for E.S.P.H.S. members as long as they acted quickly to reserve them. ROPEX was so well filled already because the show will be the 25th anniversary of the A.P.S. champion-of-champions competition. Many past winners of this exhibiting prize have been invited to exhibit at ROPEX '93. Ada Prill also indicated that the Society was invited to schedule and hold a meeting at ROPEX, and that a table could be made available to E.S.P.H.S. for publicity.

Ken deLisle reported that Society members had taken about 100 frames at CINCOPEX, and that the general quality of the exhibits was excellent. The members thanked Ken for a good job in coordinating the Society's participation at CINCOPEX.

The meeting was adjourned at 1:45 PM. Many members then delved into the covers that had been brought in for sale by members Doubleday, Azarkevich, and Parsons.

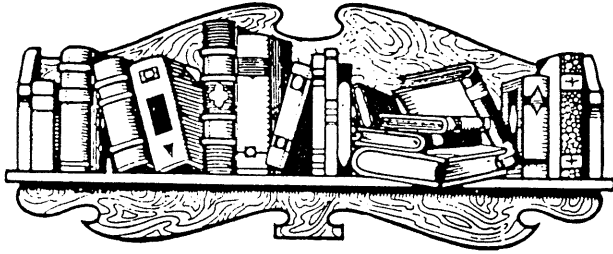

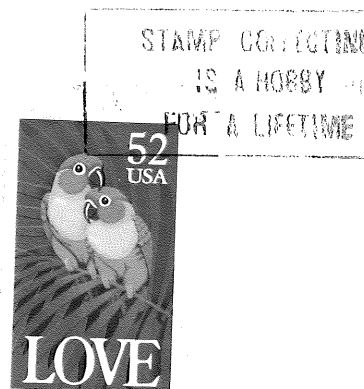
