Proposed Constitution and By-Law Changes

Your Board of Directors has recommended two changes to the Constitution and By-Laws.

The first recommendation is that the By-Laws be changed to give the Finance Committee more latitude in investing society funds in other places than a bank. When the By-Laws were first written, a regular bank was the usual place to keep money, and it provided a reasonable rate of interest. Today there are many other reliable, safe places to deposit funds for a more reasonable rate of return. The operating funds would still be kept in a regular bank, but a portion of our funds that we do not need immediate access to, and rely on for interest, could be placed in other accredited financial institutions by the Treasurer with the approval of the Finance Committee.

MINUTES OF THE ANNUAL MEETING OF THE EMPIRE STATE POSTAL HISTORY SOCIETY OF MAY 2, 1993

The annual meeting of the Empire State Postal History Society was called to order by Vice President Bob Harris at 1:38 PM. The meeting was held at Karrat's Restaurant in New Hartford, NY. Approximately 25 members and guests were in attendance.

It was noted that Karrat's had been redecorated since the Society last held a meeting there, and the meeting room was well lit and more pleasant as a result.

Charlie Edwards, Chairman of the Nominating Committee, presented the slate of candidates. No nominations had been received from the membership at large by the March 20, 1993 due date, so the Nominating Committee's slate went unopposed. The nominees were:

President - Dr. Louis T. Call Vice President - Stephen Matte Secretary-Treasurer - John Lange Directors - Charles Edwards, Gerald Wiley, Richard Lohrman

A motion was made and seconded that the Secretary cast a single ballot in favor of the slate of nominees. The motion was carried, and the ballot was symbolically cast. Thus the Society elected a new cast of officers.

For purposes of continuity, and with the tacit approval of the new officers, the out-going officers continued to preside over the meeting. Bob Harris announced that the Executive Board, at its meeting that morning, appointed William Hart and Raymond Coco to fill the Directorship vacancies created by the election of John Lange to be Secretary-Treasurer and the deletion of Dave Proulx from membership for nonpayment of dues.

It was also announced that the editorship of the Society's postal history <u>Journal</u> would be assumed by Jack Haefeli. Jack stated his intention to edit and publish two editions of the <u>Journal</u> during the 1993-94 ESPHS year.

Out-going Secretary-Treasurer Maris Tirums gave a financial report for 1992-93. The Society gained \$1502.69 during the year that ended on April 30, 1993. The full financial report is shown elsewhere in this edition of the <u>Bulletin</u>. Tirums also presented the budget for 1993-94. This budget projects a deficit of \$790 for the up-coming year. The budget was approved by the Executive Board that morning. It too is shown elsewhere in this edition of the <u>Bulletin</u>.

The out-going Secretary also presented membership statistics which show that the ESPHS currently has approximately 215 members. The expulsion of almost 30 members for nonpayment of dues last year was briefly discussed as this number was higher than normal.

Alan Parsons graciously complimented the out-going Secretary-Treasurer for his efforts during the preceding ten years in that position.

The ESPHS delegates to the Federation of Central New York Philatelic Societies are Bob Harris and Lou Call, and both of these members continue their role in the good graces of the Federation. Call recounted the details of the Federation meeting which took place at ROPEX '93 in Rochester in March. A union between the Federation and the Niagara Frontier federation was discussed at that meeting, and while Lou felt it was a useful proposal, the consensus at the Federation meeting was opposed to a merger. Call said how he was determined to make the presence of the ESPHS in western New York better felt.

Jack Haefeli stated that the ESPHS joined the Federation partly to take advantage of the publicity available through the pages of the <u>Stamp Insider</u>, and asked whether the new President intended to submit information to the <u>Insider</u> for publication in this monthly journal. Lou Call indicated that he planned to take full advantage of this avenue for publicity.

It was announced that the Executive Board approved two resolutions for amending the by-laws, and that notice of these amendments will be presented in upcoming issues of the <u>Bulletin</u>. The proposed amendments would: 1. provide more latitude for the Treasurer to invest the Society's funds in other places besides a bank; and 2. revise the by-laws to make the language therein gender neutral.

It was suggested that the Society seek ways to wisely spend some of its funds for the betterment of NYS postal history. The Executive Board will take this suggestion up at future meetings.

John Azarkevich explained how he had tried to organize an eastern regional meeting only to have the "worst blizzard of the century" spoil the plans. He asked whether the members were interested in having such a meeting rescheduled, perhaps during this summer. The response was generally positive.

David Przepiora stated how the western regional meetings had fallen off somewhat, but that the members in that area still meet occasionally. It was thought that such a meeting could be held in conjunction with philatelic exhibitions that are held in the Buffalo area.

John Lange displayed and described two types of magnifiers which he could arrange to obtain for anyone interested through professional optometry suppliers.

Maris Tirums offered for sale several plate number coil strips of five. These belong to the Society, and were excess postage from mailing the <u>Journal</u>.

The question was asked about where new information about NYS star cancellations and county and postmaster cancellations should be sent since Dave Proulx, author of the two ESPHS books on these subjects, was no longer a member. This is another subject that the Executive Board will take up at its next meeting.

John Azarkevich suggested that the Society should embark upon more publication projects partly because the sale of books and studies often becomes a profitable activity for philatelic organizations.

The annual meeting was adjourned at 2:07 PM.

Constitution and By-Law Changes

Therefore it is proposed that the portion of article 6, section 4 of the By-Laws which now reads "...and shall keep such moneys (beyond a petty cash fund not to exceed \$10.00) in a bank..." shall be changed from "a bank" to "an accredited financial institution".

The other change is really quite simple and something that many organizations are in the process of doing. That is to change the reading of the entire Constitution and By-Laws to be "gender neutral". Therefore every place where such words as "he" or "his" etc. are used, some other word will be used which does not indicate a gender. Alan Parsons, who has had some experience with this, is rewriting the Constitution and By-Laws to reflect these changes. These changes will not alter the intent of the Constitution & By-Laws in any way except to eliminate gender.

Both of these amendments are reasonable, responsible, and needed at this time. Your Directors and Treasurer all urge you to vote "yes" for both these changes.

Article 6 of the Constitution provides that the Constitution and By-Laws may be amended at any regular or special meeting of the Society by a two-thirds affirmative vote of the membership casting ballots, provided notice of the proposed change or changes shall have been given to all members in good standing at least thirty days prior to such meeting. The membership shall have the privilege of casting ballots for such amendments by mail.

This serves as the 30 day notice prior to the semi annual meeting to take place on the first Sunday in October. (Details of the place, time of day, etc. will be provided in the September Bulletin.) Members wishing to vote by mail shall mail their ballot, on any paper and in any format, to the Secretary so that he receives it prior to the semi annual meeting.
