It was an early study and served its purpose at the time, However, the APS publication, based on meticulous research into many post office records will not exactly match that early study and remains the most reliable guide to date. The Wilcox-edited tally is an interesting and mainly accurate listing of details not otherwise available.

All bids are to be in dollars and cents amounts. Minimum bid is \$2.50.

Sale will be one increment over second highest bid. Tie bids go to the earliest bidder by postmark or phone call.

Phone bids are accepted but must be confirmed by mail. High bid information will not be given out to phone bidders.

Any stated minimum bid represents consignor's reserve.

Photocopies will be sent at \$0.10 per lot and a SASE. No copies of lots with more than three items.

Payment is expected within 10 days after receipt of lots and should be made payable to <u>ESPHS</u>. Buyer pays postage and insurance—minimum of \$1.30.

Incorrectly described material may be returned within 10 days. This is exclusive of condition, which will be described to the best of the auctioneer's ability. Relatively little postal history is pristine. No return on lots containing more than 3 items.

#### Consignor's Guidelines

Lots should have a minimum retail value of \$3.00.

Owners may suggest an estimated value, but it will only be limited by the buyers minimum bid of \$2.50.

Passed lots will be charged \$0.50 and repeated one time unless otherwise requested by owner. If or when returned the owner will pay postage and insurance.

Owners may request lot reserves. Unsold, those lots will be returned with a \$2.00 minimum flat charge plus \$1.00 per lot.


Auction manager reserves right to combine or separate material submitted by same owner into suitable lots, as well as to alter any given description for the sake of consistency.

If acknowledgement is required by owner of lots sent to Auction Manger, a self addressed postal card or a list in duplicate with a SASE should be included.

Allow 6 months for the material to be listed, since the auction is quarterly.

New York State postal history material is preferred. Consignor must provide descriptions for other types of material. No off-covers stamps accepted.

The consignor's cost is 10% of the sale price, which goes to the benefit of the Society.
