### Minutes of Semi-Annual Meeting, STEPEX'98, Elmira, NY 10/17/98

1. Quorums: Five officers/directors were present, constituting a quorum for the Executive Board. An insufficient number of members were present (8), thus no quorum, For the membership meeting. One meeting was held.

Present: President Matte, Sec./Treas. Lange, Directors Guenzburger, Parsons, Tirums & Wiley with members Blazejewski, & Von Hagen + Nicholson

- 2. Nominating Committee for election of officers/d;rectors, Sunday, May 2, 1999: Nominations from a nominating committee should be in the December 98 Bulletin. The closing date for nominations to be received from the members is March 20, 1999 which is too late for the March Bulletin. If any names, proposed by the yet unnamed Nominating Committee are to be in the March Bulletin, they should be received by the Secretary by Feb. 10. The open positions are:
  - a. Director, 3 yr. term (02), Incumbent: Azarkevich (99)
  - b. Director, 3 yr. term (02), Incumbent: Lohrman (99)
  - c. Director, 3 yr. term (02), Incumbent: Wiley (99)
  - d. Director, 2 yr. term (01), Incumbent: de Lisle (98)
  - e. President, 2 yr. term (01), Incumbent: Matte
  - f. Vice President, 2 yr. term (01), Incumbent: Rowbottom

Director Parsons volunteered to be on the Nominating Committee. Tirums will ask Azarkevich to serve. Further action is required by President Matte in appointing a nominating committee.

- 3. Membership: As of 10/17/98 we have 168 members. We are losing members faster than we are gaining. The following steps have or will be taken by the Secretary:
  - a. A dues notice was inserted in the March and June Bulletins.
- b. A dues notice was sent by first class mail on July 1 to each person who had not paid. There were 48 unpaid at this point.
  - c. A second dues notice was sent by first class mail on August 22, from which a few more responded.
- d. Next spring, following the suggesting of two late payers, the Secretary plans to send a first class letter (dues notice) our entire membership. These people advised me that they need a notice separate from the Bulletin as they may not read the Bulletin when received.

President Matte asked for suggestions; there were none.

4. Awards Committee, Al Guenzburger, Chairman: An award was purchased for STEPEX'98 (a very nice clock). Six qualifying exhibits had been entered. The Best New York State Postal History Award was presented to John A.Lange, Jr. for his exhibit: Saratoga Springs, NY Stampless Covers, 1820-1855.

An award will be provided for ROPEX 99 if criteria are met. It is unknown whether the ROPEX prospectus will indicate a possible award. Guenzburger will investigate and determine the best course to follow.

- 5. President's Award: Following the meeting, a four page competition involving New York Postal History was held. Matte and Tirums judged. The winner was Gerald Wiley with his presentation of Thousand Island Hotels. The award is a plaque in the shape of NYS which will be engraved and formally presented to Gerald at our May 2, 1999 Annual Meeting. Congratulations, Gerald!
- 6. Auction at Society meetings: Proposal to change Bylaws.

The anticipated auction at our meetings isn't working (we have yet to have our first). In this connection, Director Guenzburger pointed out that conflicts with shows are the possible cause. He feels that either deliberate (continued on page 9)





avoidance or coincidence with show dates would be better than our annual meeting date of the first Sunday in May required by ESPHS bylaws. Guenzburger requested Secretary Lange to prepare a proposed revision of the Bylaws to accommodate. Lange declines, saying that he was not in favor of changing because of the relationship of other dates (elections, date of nominations closing, notification to members and Bulletin mailing dates.) However, Guenzburger was given a copy of the Constitution and was invited to write up the specific language changes that he wanted and present them.

- 7. Sweeting book, 200 YEARS OF CAYUGA COUNTY, NY POSTAL HISTORY: We have sold 15 to dealers sand 11 more (including 3 at STEPEX '98) for a total of 26. Sales are stagnant at this point. We have 74 copies left of the original 102. A review has been published in *Linn's*, the review in *Stamps/Mekeel's* will be next week (published as forecast) and the review in the *American Philatelist* is hopefully coming. (ed. note: a lengthy review appeared in the November issue of *Global Stamp News*.) Only ten copies have been purchased by ESPHS members. The book is outstanding and an extremely low price for this high quality. These comments were from the Secretary; no other comments were offered.
- 8. Input to the Treasurer, re Budget for 99--00: The Secretary/Treasurer requests that any budget input, such as funding for proposed publications, etc. be given to the Treasurer prior to April, 99
- 9. Doane Cancel book: Maris Tirums anticipates finishing approximately May, 1999.
- 10. MSPO Master Supplement: Douglas Penwell, the editor, has advised the Secretary that he is almost finished. (The week after this meeting, a manuscript was received from Douglas. Some editorial changes are being discussed with the Editor; in addition the process of copyrighting the supplement will extend any publishing date into 1999). We are close!
- 11. Bulletin/Journal: Both publications have enthusiastic editors, they are being produced and mailed in a timely fashion and are of excellent quality. Both Glenn Estus (Bulletin editor) and Martin Margulis (Journal Editor) received the thanks of those present. Drew Nicholson mentioned that if the need arose, he would be available.
- 12. Cover Mania: Director John Nunes asked the Secretary to announce that he is arranging Cover Mania, a covers only bourse at the Latham, NY Holiday Inn (near Albany), tentatively (now firm 11/17) Saturday and Sunday, February 20-21, 1999; June 19-20, 1999; and the third weekend in November. He expects to have a minimum of 14 dealers. The Latham location is approximately a 4 1/2 hour drive for some dealers (New Hampshire and PA, for example) and is being done at their request in addition to his own enthusiasm for such an event. This will be a great opportunity for ESPHS members, as the bourse is expected to have covers only and thus will gather together the right dealers for Postal History Collectors. Exact dates will be in the Bulletin.
- 13. Annual Meeting location for May 2, 1999: The desired location is in Canastota, the same as the last several years. Despite the near non-participation from the Syracuse and Rochester areas, it is more centrally located from the Albany, Southern Tier and northern areas than some other choices. President Matte will contact Joe Rowbottom to arrange.
