Retiring director Ken de Lisle has not been replaced and will continue on the Finance Committee with John Lange and myself. Ken's many years of service and contributions to the Society are second to none. I am grateful for his continued interest and willingness to serve on the Finance Committee.

Both of these are excellent publications and represent many years of work. At the annual meeting May 2, I had the pleasure of announcing that Charlie would receive the Society's first John S. Whittlesey Memorial Award for his outstanding contribution to New York postal history literature during 1998. The Whittlesey award is not an annual event but is granted, as the occasion arises, for some outstanding New York Postal history literature effort.

May 2, 1999 Annual Meeting

Graziano's Casa Mia in Canastota, NY

Vice President Joe Rowbottom chaired the meeting in the absence of President Matte. The following members (plus guests) were present: Beiderbecke, Cali, Call, Guenzburger, Haefeli, Lange, Parsons, Rowbottom, Sweeting, Tuttle, Tirums and Wiley.

- 1. The Treasurer's Annual report (previously approved by the Finance Committee) was presented. It was accepted with an addition to the proposed budget for 99-00 of \$200 for a bulk mail permit.
- 2. Awards--Albert Guenzburger Chm. Using an increased budget this year of \$500, a handsome clock (\$115.56) was given at STEPEX 98 while at ROPEX 99 two awards [a Waterford crystal bowl and Waterford crystal clock (\$265.37)] were presented. The Awards Committee is thus encouraging future exhibitors and intends to continue this effort. Also, the President's Award, in the form of a plaque with an outline of NY State was presented to Gerald Wiley for his October '98 four page showing of **Thousand Island Hotels**.
- John S. Whittlesey Committee Report, Alan Parsons, Chm. Alan announced an award for an outstanding philatelic book "200 Years of Cayuga County, NY Postal History." The author is Charles Sweeting. The Award will be a philatelic book plus a plaque to be awarded in October.

Chairman Alan Parsons announced that the President's Award (a plaque) will be the focus of our third annual four page postal history competition to be held at our fall meeting.

- 3. Status of publications:
- 3.1 Doane Cancels (Maris Tirums). Nearly finished, estimate near the end of '99. Maris distributed an outline and showed typical pages of various sections.
- 3.2 "200 Years of Cayuga County NY Postal History" by Charles Sweeting. Out of 102 copies printed, 43 have been sold at a total price of \$1232 (publication cost was \$1533.90) so we are fairly close to the break even point
 - 3.3 Star Cancels Revision by David Williams. Information not submitted.
- 3.4 Federation Insider: Alan Parsons plans to use our page in the Insider for a different series of postal history notes.

All bids are to be in dollars and cents amounts. Minimum bid is \$2.50. The Auction Manager reserves the right to reject unrealistic bids or withdraw any lot. Estimated or catalog values, where stated, are intended only as guidelines to reflect the quality of the lot.

Sale will be one increment over second highest bid. Tie bids go to the earliest bidder by postmark or phone call.

Phone bids are accepted but must be confirmed by mail. High bid information will not be given out to phone bidders.

Any stated minimum bid represents consignor's reserve.

Photocopies will be sent at \$0.10 per lot and a SASE. No copies of lots with more than three items.

Payment is expected within 10 days after receipt of lots and should be made payable to <u>ESPHS</u>. Buyer pays postage and insurance—minimum of \$1.30.
