# President's Letter: Fall Meeting October 3 at SYRAPEX '99

Annual 4-page Exhibit Competition for deLisle Award

### Postal History Exhibiting Talk by Member Bill Bauer

Don't miss the Fall Meeting. It promises to be a good one, and it's being held at a stamp show (SYRAPEX '99) with all the attractions this provides: dealers, exhibits, USPS station, youth area, pictorial cancel and more.

Statewide meetings of the Society are held only twice a year, in the spring and fall. The annual meeting is held in the spring, but not in conjunction with a stamp show; recent attendance has been light.

In an effort to improve attendance at the fall meeting as well as to encourage New York postal history exhibiting, the Society has recruited one of its members, William H. Bauer, to outline for us the elements of postal history exhibiting and respond to questions. Bill is a successful postal history exhibitor (both New York and Colorado). A former APS president, he has also chaired the Judges Accreditation Committee for the APS and he taught the course on "Exhibiting and Judging" at the most recent APS summer seminar.

All members are encouraged to bring to the meeting four pages of New York postal history material (four pages that "fit together" in some logical fashion) for the Society's annual four-page exhibit competition, with the winner to be selected by vote of the members present. The winner will be presented with the Kenneth R. deLisle Award (walnut plaque outline of New York State) at the annual meeting in May, 2000. Gerald Wiley, an active member of the Society and one of our directors, won last year's four page competition with Thousand Islands Hotels and John Lange, our secretary/treasurer, won the first annual four-page competition in 1997 with Postal Routes in the Stampless Era.

There will be a short business meeting, including reports on Society publications in process, and an opportunity for members present to offer suggestions for ways to increase participation in the Society's activities.

The first John S. Whittlesey memorial award for an outstanding contribution to New York postal history literature will be presented to Charles Sweeting, author of "200 Years of Cayuga County Postal History" published in 1998. This fine work, as well as other Society publications, will be available for purchase at the meeting.



### A New York Postal History Note by Alan Parsons

(ed. note: this article originally appeared in THE STAMP INSIDER, a magazine for stamp clubs and their members that belong to the Central New York Federation of Philatelic Societies. ESPHS also belongs and contributes a Postal History Note each issue. Since many of our members may not receive the publication, the article is being reproduced here.)

Watkins, New York (changed to Watkins Glen in 1926) has been the County seat of Schuyler since it was formed from Tompkins, Steuben and Chemung Counties in 1854.

The Watkins post office came into existence in 1829, when Watkins, then knows as Salubria, was part of Tioga County. Salubria was included in Chemung County when this County was formed in 1836. The name remained Salubria until 1852, when it was changed to Watkins. Postal markings are known for all the town names, but perhaps the most interesting (and collectible) are those fro the period 1869-1876 when the postmaster(s) indulged in a variety of fancy "killers".



One of these, a "four-point star-in-square" is shown here on the 1¢ 1869. This particular cancel is listed in Skinner/Eno, "United States Cancellations 1845-1869" under both geometric and star designs.

Other fancy cancels used during this period (most are listed in various reference works) included shield designs, circular geometries, letter W (both positive, negative and in circle), so-called "outline" or negative stars, "patriotics" (negative US in square or circular frame), positive stars and large numeral year dates 1870, 1871, and 1876 (the latter in circle). It's a challenging area to research and collect.


