President's Message:

Society had full agenda at fall meeting in Syracuse

Fourteen members plus two spouses attended the semiannual meeting of the Society at SYRAPEX 199 in Syracuse October 3rd. I was encouraged by this turnout at my first meeting as President and hope that more will attend in the future.

Certainly one of the highlights of the meeting was Bill Bauer's talk on postal history exhibiting. Hopefully, it stimulated more interest in exhibiting; it would appear this way from the questions Bill had from the audience. A personal highlight for me at the meeting was presenting Charles H. Sweeting with the first John S. Whittlesey Memorial Award for his 1998 book "200 Years of Cayuga County, NY Postal History." The award consisted of a N.Y. outline plaque plus a hardbound copy of James W. Milgram's recently published "United States Registered Mail 1845-1875" with appropriate book plate. Charles Sweeting is the founder of the Society and has served many terms on the Society's Board. The purpose of the John S. Whittlesey Award is to recognize a compiler or editor of a publication which adds significantly to the knowledge and/or understanding of some facet of N.Y. Postal History. Charlie's wife, Betsy, was present at the meeting and although the plaque and bookplate do not list her name along with his, she has certainly been a vital part of his accomplishment and this is fully acknowledged by Charlie in his dedication of the book.

Save the date now and plan to attend our annual meeting in 2000 - Sunday, May 7, at Graziano's Casa Mia Restaurant in Canastota, N.Y.

In closing, I wish to thank Steve Matte and Lou Call for agreeing to serve as the nominating committee for elections at our annual meeting next year, Alan Swift (SYRAPEX '99 Chairman) for the arrangements for our fall meeting at the Carrier Circle Holiday Inn in Syracuse, and our diligent Secretary-Treasurer, John Lange, for his ever-thorough meeting preparations.

CLOSE VOTE MARKS THIRD ANNUAL deLISLE FOUR-PAGE EXHIBIT COMPETITION

Four succinct and informative New York postal history presentations were entered in the 3rd annual Kenneth R. deLisle Four-Page Exhibit Competition held at the Society's fall meeting.

Each exhibit dealt with a short but interesting chapter in the postal history of a New York locality, to wit (locality followed by name of exhibitor): Glens Falls - Bill Hart, Watkins/Watkins Glen - Al Parsons, Ballston/Ballston Spa - John Lange, and Camp Whitman - Drew Nicholson.

It was hard to choose the "best" entry among the four. Thirteen members cast ballots and the vote was split as evenly as possible: Watkins Fancy Cancels 1869-1875 received four votes and each of the other entries three votes. If the rules of the competition had required the winner to receive a majority of the ballots cast, we might still be voting!

Parsons was heard to remark, to anyone who would listen, that he did not vote for his own exhibit.

The next Four-Page Exhibit Competition will be held at the Society's semi-annual meeting in the fall of 2000 (exact date and location to be determined).

NEW YORK POSTAL HISTORY AWARDS PRESENTED FOR SYRAPEX '99 AND STEPEX '99

SYRAPEX '99, held October 2 and 3 in Syracuse, had two New York postal history exhibits entered in competition: John Lange's Waterford-Saratoga County, NY Town Markings in the Stampless Period and Al Parsons' Corning, NY to 1900, each a three-frame, forty-eight page exhibit. Judges for the ESPHS Award were Bill Bauer, Cliff Tuttle, Lou Call and Al Guenzburger. They selected Corning, NY to 1900 for this honor.

At STEPEX '99 October 22 and 23 in Horseheads, NY (sponsored by the Elmira Stamp Club) four postal history exhibits were entered, one of which, Corning, NY to 1900, was ineligible for the ESPHS Award because it had already received it at SYRAPEX. The three eligible exhibits were: Waterford-Saratoga County, NY Town Markings in the Stampless Period, A Selection of Allegany County Manuscript Post Offices on 19th Century Covers (Bill Howden) and A Survey of Staten island (Richmond County) Postal History (Martin Margulis).

Judges for STEPEX '99 were Albert Guenzburger, Chief Judge, assisted by Maris Tirums and Roger Quinby. Their choice for the ESPHS Award was John Lange's Waterford-Saratoga County, NY Town Markings in the Stampless Period,

Al and John have received Waterford Crystal Clocks with appropriately engraved plates for their recent ESPHS exhibiting awards.

The next New York shows for which ESPHS Awards are available if sufficient entries are received (two minimum) are ROPEX 2000 in Rochester March 17-19, BUFFPEX 2000 in Buffalo March 31 - April 2 and Spring Postage Stamp MEGA event in New York City April 6 - 9. Letter from Auction Manager

To: E.S.P.H.S Members

From: Bill Hart, Auction Manger RE: Future E.S.P.H.S Auctions

It has been apparent in the course of presenting the auction for several years that it has been running downhill. There are some obvious reasons. Those members with the more mature collections rarely bid, finding nothing new. In recent auctions, newer members are the predominant bidders. In general the bidding appears to be limited by the the distinctiveness of the material being presented. It is quite apparent that of the thirty or more larger offices across New York, the stampless cancels listed by Bernadt as most common really have no market. With manuscript cancels the earliest are the preferred lots. To get more bidders we need more distinctive material.

You all know that the auction exists for the benefit of the members to both buy and sell. It is necessary at this time to reestablish the need for an auction. The last seven sales have had a total of only 22 member consignors and only 7 have material in more than one sale. The slack was made up by myself and some outside sources. There is no member material on hand as this is written in early November. I believe that the current format is slanted toward the bidder. To get more consignors we need a different approach.

Henceforth, we will conduct a two-tier auction. One level will be for better material with bidding constraints and owner protection. The other will be for more common material with minimum description and a \$2.00 starting bid with no reserve. New buyers rules and consignor guidelines accompany this letter. Please read them carefully and send in your good material.

There will be no December auction. For the March 2000 Auction, material should be in my hands by January 15, 2000

1. Award Committee, Chairman: Guenzburger:

Alan Parsons is the winner of the ESPHS competition at SYRAPEX with his three frame exhibit of "Corning, New York Postal History." Alan will received the award at a later time, a beautiful Waterford crystal clock

There are also four qualifying exhibits for STEPEX '99 to be held in Elmirea on Oct. 22, 23 so it is planned to give a similar award then.

2. Secretary Lange: As of Oct. 3, there are only 9 dropped members, about 5% which is very good. At present, we have 175 members. Last year at this time we had 168 members.

3. E-mail addresses & web site, Parsons:

Suggestions have been received from Glenn Estus and Douglas Penwell suggesting their setup. The goal is eventual incorportation in the membership list. Consignor Guidelines

The E.S.P.H.S. Auctions will be carried out in two parts where better material will be separated from the more common material. There will be no lotting charges and unsold lots will be returned without charge after each auction. Owners should classify material according to the following descriptions.

Better material will be described in detail. The owners **must** provide a minimum bid for each lot considered better material. \$10.00 will be the minimum starting bid, but a minimum value of \$20.00 is encouraged.

More common material will be given one line descriptions. The starting bid for each lot is \$2.00. Lots will have no reserves, but owners may provide an estimated value.

Bidding increments are \$0.50 up to \$10.00, \$1.00 from \$10.00 to \$40.00, \$2.50 from \$40.00 to \$100.00 and \$5.00 over \$100.00.

Auction manager reserves the right to combine or separate material submitted by the same owner into suitable lots, as well as to alter given descriptions for consistency and to withdraw lots.

NY postal history is preferred. Consignors are encouraged to provide descriptions for other types of material. No off-cover stamps are accepted. Please allow 6 months for material to be listed, since the auction is quarterly. The consignor's fee is 10% of the sale price to the Society's benefit.

If acknowledgement is required by the owner of the lots sent to the Auction Manager, a self addressed postal card or a list in duplicate with a SASE should be enclosed. Consignments should be sent to: E.S.P.H.S., Box 167, Shrub Oak, NY 10588.

Buyers' Rules

The auction is presented in two parts — the first having scarcer or better material and the latter with more common material.

Better material will be identified with minimum bids with minimum bids established by the owner. The minimums start at \$10.00. These lots will have detailed descriptions.

More common material will have a one line description and require a starting bid of \$2.00. This group will have no lot reserves but some lots may be given estimated values.

Sale will be at one increment over second highest bid. Tie bids go to the earliest bidder by mail or phone [(914) 245-1825]. The latter must be confirmed by mail. Bidding increments are \$0.50 up to \$10.00, \$1.00 from \$10.00 to \$40.00, \$2.50 from \$40.00 to \$100.00 and \$5.00 over \$100.00

Payment is expected to be sent within 5 days after receipt of lots. Checks should be made out to E.S.P.H.S. and sent to Box 167, Shrub Oak, NY 10588.

Photocopies will be sent at \$0.10 per lot and a SASE. No copies of lots with more than three items. Incorrectly described material may be returned within 5 days. This is exclusive of condition, which will be described to the best of the auctioneer's ability. Relatively little postal history is pristine. No returns of lots containing more than 3 items.

AN ULSTER COUNTY SAMPLER


New York State was comprised of ten original counties when statehood was first established on July 26, 1788. Ulster County, located on the west side of the Hudson about midway between New York City and Albany, was one of those original ten counties. The postal history of Ulster County is among the earliest of the State, and indeed, of the United States.

Kingston is Ulster County's only city. The post office at Kingston was established on June 12, 1792. Kingston was New York State's first capital for a brief period in 1777, and today is the Ulster County seat.

The Rondout Creek is a major tributary to the Hudson River. In the 19th century, a bustling, industrial and commercial community known as Rondout formed on the north side of the Rondout Creek. Kingston was located a short distance north of Rondout, and as the area developed, the two communities became joined first physically, and then politically as Rondout and Kingston were united in May 1872.

For many years after Rondout was united with Kingston, the post office in the southern part of the City retained the name Rondout, and in 1898, this became the Rondout Station of the Kingston post office. This designation was used on machine cancellations used at that post office.

Shown here is a stampless cover with a RONDOUT circular date stamp from 1838. The second illustration is of a black-bordered "mourning-" envelope with a Rondout Station machine cancel from 1905.
