#### PRESIDENT'S MESSAGE:

As I look forward to the annual meeting in May I am pleased to report on a regional gathering at Cover Mania in Albany Feb. 17 attended by Society members Bob Davison, Greg Stone, Charlie Sweeting, John Nunes, our Secretary-Treasurer John Lange and myself. Charlie Sweeting had with him the "prototype" of his forthcoming book on Oswego County postal history, co-authored with his daughter Heather Sweeting. Charlie's sharing of this new book with the others in attendance, and showing how the authors have organized the wealth of information it contains, was clearly the highlight of the meeting.

Other Society members I visited with, or purchased covers from, or both, at Cover Mania, included Maris Tirums, Drew Nicholson, Henry Chlanda, Bill Hart, Elwyn Doubleday, John Azarkevich, Carl Blazejewski, Don Tocher, Arnie Leiter (Uncle Sam Stamp & Coin), Bill Sammis and Al Tohn (Coverman). Clearly the ESPHS was well represented. Thanks to John Nunes for all his work in staging Cover Mania and for giving the Society an opportunity to gather.

Another regional gathering will be held at ROPEX in Rochester on Saturday, March 17 (check at reception desk for time and room location). I look forward to seeing many of you who were unable to attend Cover Mania.

Bill Hart, our auction manager, received a nice tribute in Charles Moore's bi-weekly column, *Special Delivery*, published in *The Life and Times of Utica*, a weekly, last November. The writer had attended STEPEX '00 in Horseheads where Bill Hart was included among the dealers. He wrote favorably of the experience, including these words concerning the dealers:

"Most dealers are happy to give advice and guidance to a new collector or even an experienced one. A case in point is a dealer by the name of William Hart who had a large selection of postal history of New York State. He had many hundreds of covers to look over. A cover is a postally-used envelope. I mentioned to him I was just starting a collection of postmarks from the post offices of Clinton County in upstate New York. He not only had many covers to show me but took the time to give me several lessons on the postal history of New York. I made several purchases from him. However the information he passed on to me was far more valuable."

When sending information, please be very specific as to town spelling (and whether a county cancel as well), color of star, type of star using the Proulx book as a guide, and also the year of usage.

If possible, a clear Xerox copy of the cover is preferred, especially when the star is a new variety. But please remember to specify the color of the cancel on the Xerox. David has received some xeroxes where the color was not stated and therefore he can't determine whether the cover in question actually qualifies as a new discovery. Send all information to David E. ## February 2001 Regional Meeting

The ESPHS had a regional meeting on Saturday (held in the bar, which proved to be comfortable and quiet). My notes are:

- 1. Oswego Co. PH, the forthcoming book by our Cayuga Co. PH author, Charles Sweeting is almost finished. Charlie showed us a bulging book of the pages and took a brief tour through the contents. We may be able to announce a publication date in the June Bulletin; the plan is to make it a hard cover book; it will be about 400 pages and printed on 28 lb opaque paper as used for the Cayuga Co. book.
- 2. Nominating Committee for Pres., Vice Pres. and 3 Directors.: John Cali is the Chair, Gerald Wiley and Charles Sweeting are the other members. Charlie believes their work is completed. Other nominations will be accepted up to March 20.
- 3. Postal Route Maps: Four were given away to members present, one was sold for \$15 to a non-member and one was given as an inducement to join the ESPHS (Dr. Joseph Rudnick).
- 4. MSPO & Co-PM "Garage Sale." Very little response, as expected. It was suggested to the Secretary to make the bulk sale offer to other dealers besides Hartmann, i.e. Lee/Bansner/ Subway. This will be done in a couple of weeks.
- 5. Life Membership. A second person has elected the Life Membership option, this time Jerry Kotek, a new applicant.
- 6. LIPHS joining the ESPHS: A letter to the LIPHS president Brendan McCann was sent on Jan. 19 inviting their members to join us as a group. Since this will probably cause a poll among their members, I do not expect an immediate response.

#### Information Needed

New member, Alan Berkun, is searching for information concerning the cover pictured below.

Quoting his recent letter of inquiry:

"Enclosed is a copy of my Scott 114 (3c 1869 Locomotive stamp) on cover. As you can see it has an ALBANY postmark dated March 22, (year date not on the cover). My inquiry is quite simple: **To determine if the year date is 1869**. The cover would be the earliest recorded usage of the 114 on cover and the second earliest of the series. I already own the 2 cent on a March 20th, 1869 from NYC.


"My inquiry is as follows:

"Have any of the society members collected Albany postmarks? If so maybe they know if the postmark or obliterating mark changed from 1869 to 1870? If so this could date my cover by comparison.

"Also the addressee may be from a known correspondence that a collector is aware or, has several others written in the period.,

"I would gladly credit the society with help, and can assure you a front page mention in Linn's Stamp News if we prove it is an 1869 usage!!"


(ed. note: Mr. Berkun is well known in the philatelic world for his earliest usages. I just finished reading his latest article in FIRST DAYS about "The FDC of the First U.S. Stamp." It's not US #1 or US #2, but US #6LB1, the US City Dispatch Post stamp used on August 16, 1842 in New York City.)
