MINUTES OF JUNE MEETING

A meeting of the Empire State Postal History Society was held on June 17, 1972 at "Ropex" in the Flagship Hotel, Rochester, N.Y. In the absence of the president, George Bernadt presided. The meeting was called to order at 11:10 A.M. 9 members present. Warren Stevens reported that \$15.00 had been authorized for the purchase of a Paul Revere Bowl as the ESPHS award at Ropex. He found it impossible to obtain the bowl at that price and had received permission from Lee DeGraff to get something suitable. The cost of the bowl was \$30.87. Motion made by Doolittle, seconded by Staplin, that purchase be approved. Carried.*

The matter of a reprint of the Post Office list was introduced. Members were asked to tell interested people that the book might cost 20 to 25 dollars, and were told to report if a reprint seems desirable. The matter was referred to the Executive Board.

EDITORIAL BY THE SECRETARY

With fiscal 1972-73 we enter our seventh year. Charlie Sweeting - way back in 1966 - sparked this organization into being when he discovered there were a number of cancellation collectors working individually on NYS postal history who might better be working collectively. Although there has been some turnover in the past few years, we have continued to grow. At the present time we number ober 90.

It would be nice to go over the 100 mark this year. To do this, we must hold our present members and attract new ones. What can we offer our membership and those who might wish to join? Certainly there is no great attraction in receiving a little green card for \$5.00.

We have produced one fine publication highly regarded by all postal historians, Federal Post Offices of New York State. Our most recent publication, Manuscript Cancellation of New York State Post Offices is the forerunner of a more complete work on the subject. From time to time the Bulletin has offered articles of postal history significance.

Last year the Executive Board announced our desire to publish a formal journal in which articles of permanent interest and historical value could be set down for the record. The two issues of Postal History mark the beginning of this effort. The Executive Board has authorized one more issue in its present format before making a decision to commit time and expense to a permanent publication.

All of these actions have been taken by the Executive Board in YOUR interests and have resulted from the work of a very few people. This is not a one-way street. In a society as small as ours each member should make some contribution. Articles for the journal cannot flow continuously from the typewriter of our editor, HE MUST HAVE AUTHORS. Each of us, I am sure, have items of postal history information in our own specificalty which could be shared with the members and with philately in general.

Let us all make a resolution to contribute a minimum of ONE article in the immediate future. The success - indeed the existence - of our proposed journal depends on the contributors. Let the publication Committee worry about photographs, format, costs and mundane problems of printing and distributing the journal. Don't create another problem by holding back on that article you have always MEANT to write.

There must be other projects this Society could attempt in addition to the journal. On each application blank there is a question - "Do you have any specific program or research project you would like to see this Society initiate?" Invariably this section is left blank or answered in the negative. But the question is not an idle one just to fill up space. The President and the Board want to know what you need, projects of interest to some of you, if not to all. The Executive Board meets in September to plan activities and allocate funds for the coming year.

Please write to Lee DeGraff if you have a pet project you would like started. Of course, you will be asked to work on it but you will not have to go it alone. We have only to know what you want.

Members who have not yet done so can make a very valuable contribution by sending Lee a list of the manuscript cancellations in their collection. This information is really needed from members and non-members alike. Make your listing similar to the arrangement used in the manuscript book - send it in without delay.

Let us all do something this year besides send in the \$5.00 and wait to be entertained!

STAMP THEFT:

We deeply regret reporting the following from Warren Stevens:

"On July 4th, our house was broken into while we were on our way home from Chicago, and all of my collections were stolen, including my cameras and projector,"

The Society wishes to express its sympathy to Warren and to express the hope he will soon recover his collections.

STAMP THEFT ACTION:

So many times we hear or read of a stamp theft and say "That's too bad, but it probably won't happen to me. THIS IS A SERIOUS MISTAKE - IT CAN HAPPEN TO YOU.

All A.P.S. Menbers are aware, through reading the articles of the Stamp Theft Committee in the American Philatelist, that every collector, large or small, is a target for the burglar. Especially since publicity has brought stamp values to the attention of those who deal in "hot" goods, philatelists have been more and more victimized.

Reams have been written on insurance, safe-keeping, etc., but the fact remains that 90% of all collections are in an unprotected residence, standing on bookshelves or in cabinets neatly in a row, inviting the burglar to take them. Bulk is no hindrance, these characters will back up a truck to your door if they have to. There are several steps a collector can take to minimize this danger.

If you MUST keep your valuables at home, scatter them. Time works against a thief and it is the experience of many victims that a collection stored in as many different places as possible is never completely taken. A.P.S. members should investigate the stamp insurance available to them. It is easy to obtain and much more reasonable in cost than commercial stamp insurance. The APS insurance is limited to collectors, dealers will not be accepted. Best of all, keep your best stamps and covers in a safe place away from home. Bank vaults are tops, but even a fire resistant file at the office is better than nothing. READ THE AMERICAN PHILATELIST.
